



## CITY COMMISSION STAFF REPORT

**DEPARTMENT:** Administration

**SUBJECT:** Discussion and possible action on a Pierce Custom Enforcer PUC Pumper – 39114 Fire Apparatus if the apparatus remains available for purchase.

**CITY MANAGER RECOMMENDATION:**

The City Manager requests a discussion and possible action on the purchase of a Pierce Custom Enforcer PUC Pumper – 39114 Fire Apparatus. If still available, it is recommended to purchase this apparatus. It is approximately \$125K less than a similar model that the City has received an estimate of, and would be available in a much quicker timeframe.

**BACKGROUND OF ITEM:**

The City's fire-rescue services are provided by contract with the Broward County Sheriff's Office (BSO). While BSO provides the staffing and fleet maintenance, the City is responsible for the purchase of the apparatus. The City is in the process of analyzing and preparing for the purchase of new fire apparatus.

**ANALYSIS:**

We have been made aware by BSO of a Stock Pierce Custom Enforcer PUC Pumper – 39114 Fire Apparatus for \$840,131 plus approximately \$25,000 in additional equipment that may be available as early as late January 2023. However, this apparatus is being made available to multiple municipalities and therefore its availability is not certain.

Section 2-258(i) of the City Code authorizes the City to waive procurement procedures when it is in the City's best interest to do so.

(i)Waiver of procurement procedures. The City Commission may authorize the waiver of procurement procedures upon the recommendation of the City Manager that it is in the City's best interest to do so to obtain goods and services which cannot be acquired through the normal purchasing process due to insufficient time, the nature of the goods or services, or other factors. Purchases authorized by the waiver process shall be acquired with such competition as is practicable under the circumstances and only after a good faith review of all available sources and negotiation as to price, delivery, and terms. There shall be no waiver of procurement procedures for procurements that are subject to the provisions of F.S. §§ 287.055 or 255.20 as amended.
