

**CONTRACT RENEWAL**

THIS CONTRACT RENEWAL is entered into by and between the CITY OF DEERFIELD BEACH (CITY), a municipal corporation and SATCO (CONTRACTOR), as follows

**WITNESSETH:**

**WHEREAS**, the CITY and CONTRACTOR entered into an agreement for Sulfuric Acid 93% for Water Treatment Plant Operations pursuant to ITB 2018-19/22; and

**WHEREAS**, the initial CONTRACT term is three (3) years, beginning June 1, 2019 and expiring May 31, 2022; and

**WHEREAS**, the terms and conditions of the CONTRACT provide three (3) additional one (1) year renewal options; and

**WHEREAS**, the CITY is exercising the right to extend the contract for the third (3<sup>rd</sup>) of the three (3) renewal periods; and

**WHEREAS**, renewal of the CONTRACT is in the best interest of the City;

**NOW THEREFORE**, be it agreed by and between the parties as follows:

- Section 1.** The above referenced Whereas clauses are true and correct and made a part hereof.
- Section 2.** The contract renewal term shall begin on June 1, 2024 and will expire on May 31, 2025, (There are no more renewals) unless otherwise terminated pursuant to the terms of the original CONTRACT.
- Section 3.** All terms, conditions, and specifications of the original CONTRACT shall remain the same.
