# **REGULAR AGENDA**

# 8. Discussion and possible action on implementing a Community Garden in Cooper City. – Commissioner Mallozzi

Commissioner Mallozzi said there are a few cities throughout the county that have a community garden. It is a great tool for teaching the youth and also feeding the community. She does not believe there will be much of an initial investment and the area is available in the easement of Monterra.

Commissioner Smith said he is aware of other cities that do have a community garden. He asked if volunteer groups would head the initiative. Commissioner Mallozzi answered yes, there are a lot of clubs in the High School that can take the lead. Commissioner Smith asked if we can partner with the school that has a program already established. Commissioner Mallozzi said the schools have small planting areas. This initiative would be a larger. Commissioner Mallozzi said there are needy families in the area that could use the food. Commissioner Smith said while he believes it is a wonderful idea he has concerns that if the volunteers dwindle the responsibilities will fall to the City. Commissioner Mallozzi said if the volunteers are not available they can close the garden.

Commissioner Katzman loves the idea in theory. He would also like our communication channels to let residents know there are resources available to help anyone in need of food. The City is in the middle of a beautification plan and he does not want to add too much at one time. He would prefer a timeline for the idea.

Commissioner Mallozzi said they can ask the Green Advisory Board to help with the program.

Commissioner Shrouder asked the location and size of the garden. Commissioner Mallozzi said 30x110 feet and the proposed area is the easement in Monterra.

Commissioner Shrouder said if there is a group that wants the project he believes they should support it. However, he does not want the City to have to take over maintenance and the responsibility of finding volunteers.

Commissioner Mallozzi said she received permission from FPL. Commissioner Shrouder stated she may need permission from Monterra as well.

Commissioner Shrouder asked how much money the City may need to dedicate to the program. Commissioner Mallozzi said a few hundred dollars. However, she is not looking for the money now.

City Manager Rey said he does not want to dedicate any City staff to the program.

Commissioner Shrouder suggested that the group interested in running the program submit a proposal to the City.

Commissioner Smith asked if the individuals interested can speak to the Commission during public comment.

Mayor Curran would love to see what the garden would look like and to see a more defined plan.

Commissioner Mallozzi said she has had several individuals approach her about food banks.

Commissioner Shrouder said Commissioner Mallozzi can work with Community Development Director Carlos Vega to find available easements.

# 9. Discussion and Possible action on the "Don't Block the Box Initiative" to keep the traffic flowing. – Commissioner Mallozzi

Commissioner Mallozzi said several residents near 49<sup>th</sup> Street and 90<sup>th</sup> Avenue have spoken to her about issues they are having not being able to exit.

Commissioner Smith moved to approve the item. Mayor Curran seconded the motion.

Commissioner Shrouder and Katzman asked the locations.

Commissioner Shrouder asked the cost.

Commissioner Smith suggested they try the initiative first at 49<sup>th</sup> Street and 90<sup>th</sup> Avenue.

Commissioner Shrouder asked that the signage be aesthetically pleasing.

**MOTION:** Commissioner Smith moved to approve the "Don't Block the Box Initiative" near 49<sup>th</sup> Street and 90<sup>th</sup> Avenue. Mayor Curran seconded the motion which prevailed by a unanimous roll call vote. (5-0)

#### 10. Discussion and Possible Action on Selling Cooper City Merchandise. - Commissioner Mallozzi

Commissioner Mallozzi said the Publix on Palm Avenue and Griffin Road is selling Cooper City merchandise. She stated she has been asked by residents about City merchandise and is hoping this can bring revenue to the City.

Commissioner Shrouder suggested she work with the Parks and Recreation Department and produce a few shirts.

Commissioner Smith asked when and where a patron would receive and order the merchandise. Commissioner Mallozzi said the merchandise can be displayed at City Hall.

Commissioner Shrouder said they can be made available at the Community Center.

Commissioner Katzman said inventory can be an issue and this could be costly.

Commissioner Mallozzi said Publix is selling T-shirts for \$19 dollars. She thought this could possibly help raise funds for the City.

Mayor Curran does not believe selling clothing is a thriving business.

There was no consensus or action on item 10.

Commissioner Mallozzi asked that the City utilize the government website for future items.

Commissioner Katzman asked the City Manager Rey to explain the item. City Manager Rey said this equipment will help fertilize the fields bringing them up to condition.

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF A WATER AND SEWER DEVELOPER'S AGREEMENT WITH FIRST BAPTIST CHURCH OF SOUTHWEST BROWARD, INC., FOR THEIR BUILDING ADDITION PROJECT FOR EIGHT WATER AND EIGHT SEWER ERC'S AT A TOTAL COST OF \$30,525.36, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING AND DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Shrouder asked that we print the names for the witnesses before recording.

**MOTION:** Commissioner Smith moved to approve Resolution 25-11. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

# 13. Resolution 25-13 (Utilities)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF A WATER AND SEWER SERVICE AGREEMENT FOR WATER SERVICES OUTSIDE OF THE CITY LIMITS TO THE ARCHDIOCESE OF MIAMI

EDWARD A. McCarthy High School, located at 5451 SW 124th Avenue, within the town of southwest ranches, florida, for 1 water erc at a total cost of \$1,798.52, attached hereto as exhibit "a" and incorporated herein; authorizing and directing the appropriate city officials to take any and all actions necessary to effectuate the intent of this resolution; providing for conflicts; providing for severability; and providing for an effective date" by title.

City Attorney Horowitz said last year the Commission adopted an ordinance amending a provision of the utility code to provide that the City would only serve parcels outside of its boundaries in the event that the Commission supported the use that was being proposed and that the use was not in conflict with the health, safety, and welfare of the City. He had a conversation earlier today with Commissioner Shrouder were they talked about adding a clause to the resolution to embrace that specific code language which was adopted last year. If the item is adopted his intention is to add that language to ensure that that particular provision in the code is captured in the resolution.

Commissioner Mallozzi said last year this area did not accurately pay for water due to a faulty meter. She asked if money was recuperated. She also asked that staff monitor large entities to assure the meters are working. City Manager Rey said staff has started the process of installing smart meters. He recommends the Commission approve the item and if there is any concern on recouping the money he can report it to the Commission.

Commissioner Katzman asked if when water and sewer agreements are sought staff looks any fees owed to the City. City Attorney Horowitz said there are limitations particularly with regards to landlord and tenants but they can look into a process.

**MOTION:** Commissioner Shrouder moved to approve Resolution 25-13 to include specific code language which was adopted last year. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

#### **ORDINANCES ON FIRST READING**

# 14. Ordinance 25-07 (Commission)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING THE CITY'S CODE OF ORDINANCES BY AMENDING CHAPTER 2, ENTITLED "ADMINISTRATION," ARTICLE II ENTITLED, "CITY COMMISSION;" SPECIFICALLY AMENDING SECTION 2-21, ENTITLED "REGULAR MEETINGS;" PROVIDING FOR ONE (1) WORKSHOP MEETING AND ONE (1) REGULAR MEETING OF THE CITY COMMISSION EACH MONTH; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE" by title.

Commissioner Smith said there are times when the Commission needs to discuss items before voting. A workshop would allow the Commission to be able to handle business at a Regular Commission Meeting.

Commissioner Shrouder understands the intent but does not believe meetings should be adopted by ordinances. At a workshop they cannot vote on any matters and that can limit staff. He stated the Special Recognition Meetings were developed for recognitions not to be placed on regular meetings. While he

understands the intent he does not want to limit staff to one meeting for action items. He suggested having one meeting that is more of a working meeting but still allow for voting on items.

City Attorney Horowitz said the code requires two meetings per month that can be amended by resolution from time to time.

City Manager Rey said in his experience if there are complex items he has seen special meetings called.

City Attorney Horowitz said most cities have two meetings per month as we do. Many Cities have two workshops before Commission Meetings.

Commissioner Smith said this offers new autonomy that the Commission has not seen before.

Commissioner Katzman said having a meeting where the Commission cannot vote will tie the hands of the Commission. He understands some items warrant a workshop or special meeting but he has issues with limiting the ability of the commission to vote. He also stated ordinances require two readings and this would delay the readings.

Commissioner Mallozzi does not want to add additional meetings and overload staff.

Commissioner Smith said he is not recommending additional meetings.

Commissioner Smith was recommending a meeting for debating and a meeting for business.

Commissioner Mallozzi recommends no change to the two regular meetings they have currently.

Commissioner Shrouder prefers the Commission agrees amongst themselves to have a meeting more streamlined and one that has the additional items the Commission requests.

Commissioner Smith is onboard with whatever would work and asked that the vote be called.

**MOTION:** Commissioner Smith moved to approve Ordinance 25-07. Commissioner Shrouder seconded the motion which failed by a unanimous roll call vote. (5-0)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER 21 OF THE CITY'S CODE OF ORDINANCES, ENTITLED "UNIFIED LAND DEVELOPMENT CODE;" BY SPECIFICALLY AMENDING SECTION 21-6, ENTITLED "ENFORCEMENT AND PENALTIES;" PROVIDING FOR THE ENFORCEMENT OF THE CITY'S UNIFIED LA ND DEVELOPMENT CODE THROUGH THE CODE ENFORCEMENT PROCESS PURSUANT TO CH. 162, F.S.; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE" by title. — Commissioner Shrouder

**MOTION:** Commissioner Shrouder moved to approve Ordinance 25-08. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

City Attorney Horowitz read "AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER 17 OF THE CITY'S CODE OF ORDINANCES, ENTITLED "TRAFFIC AND MOTOR VEHICLES;" BY AMENDING ARTICLE II ENTITLED, "PARKING, STOPPING AND STANDING;" AMENDING SECTION 17-16 ENTITLED "PARKING PLACES FOR HANDICAPPED PERSONS;" AMENDING SECTION 17-17 ENTITLED "CITATIONS FOR PARKING VIOLATIONS;" AMENDING SECTION 17-18 ENTITLED "PROHIBITED STOPPING, STANDING OR PARKING ON CERTAIN ROADWAYS;" AMENDING SECTION 17-19 ENTITLED "PROHIBITED PARKING, ADDITIONAL REGULATIONS;" AMENDING SECTION 13-82, ENTITLED "CITATIONS — OPTIONS OF PERSONS CITED;" PROVIDING FOR CERTAIN REGULATIONS RELATED TO SWALE PARKING; PROVIDING FOR PENALTIES; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE" by title.

City Attorney Horowitz advised the fee schedule has been amended after discussion at first reading.

Mayor Curran opened the public hearing with no one wishing to speak. Mayor Curran closed the public hearing.

Commissioner Shrouder would like the fine raised to \$100 as opposed to \$50.

Commissioner Smith asked if rerouting with the schools does happen will it address the issue. City Manager Rey said this issue will be addressed but not cured.

Commissioner Shrouder said the fee should be \$100 dollars as the individual does receive a warning.

**MOTION:** Commissioner Shrouder moved to approve Ordinance 25-06 with the fine raised to \$100 dollars. Commissioner Smith seconded the motion which prevailed by a unanimous roll call. (5-0)

#### **CITY MANAGER REPORT**

City Manager Rey advised there was a transfer of \$90,000 from the police contingency to labor.

Commissioner Smith said he was able to meet with staff in Utilities and stated because of their maintenance that is done internally they saved the City a million and a half dollars on filter replacement. He stated the City has great employees.

Commissioner Mallozzi thanked staff and Parks and Recreation for their help on her initiatives. She also stated next year she would like to bring back the "Say I Do" program. There is a bunco fundraising event for Relay for Life on April 4, 2025 and a pickle ball tournament on April 6, 2025. There are QR codes available for sign up. She thanked everyone who donates their time to fundraising.

Commissioner Katzman said he attended Embassy Creek Elementary Career Day and asked the class to provide ideas to the Commission. He also congratulated Griffin Elementary on their 45<sup>th</sup> anniversary.

Commissioner Shrouder said for years the City has had a lease with Pioneer Middle School for the field located behind the school. He would like to look at what the cost would be to update the fields to have more space for activities. City Manager Rey said they were waiting on the Parks Master Plan to see what the area can handle. Commissioner Shrouder does not want to wait. He would like to look at costs to bring the fields up to par.

City Manager Rey said the Parks Master Plan should be available within the next 45 days. Commissioner Shrouder asked that staff look at the area to see what they have with regard to irrigation.

Consensus was reached to look at the field condition and evaluate what the area has currently.

Mayor Curran supports looking into what the area has now and what it needs. He thanked his colleagues for attending baseballs opening day. He thanked field staff as the fields looked great. He also congratulated Griffin Elementary on their 45 year anniversary, the celebration was a great event. Founders Day will be held on Saturday March 8<sup>th</sup>, 2025. The morning portion starts at 8:30 AM with a parade at 10:30 AM. The afternoon programs starts at 3:00 PM at Brian Piccolo Park with fireworks at 8:30 PM.
