12. CITY MANAGER REPORT

Mr. Loucks provided an update on the Palm Avenue project and clarified that this is a Broward County project which is now on a brief hold while the county resolves a bid dispute regarding the construction portion of the project.

13. OPEN PUBLIC MEETING

Ed Wooley, 11038 Nashville Drive, commented regarding the BSO contract with the City, the cost of emergency transport, budget reserves, fees and taxes.

Gladys Wilson, 5155 SW 90th Avenue, commented on the decisions of the Commission regarding taxes, fees, programs, transportation and the dissemination of community service information.

Patty Fentner, 5383 SW 120th Avenue, asked that her contact information be available to community members who need assistance with their hurricane shutters.

Walt Jolliff, 11095 Bismarck Place, commented on the CAFR and BSO records.

Luis Padilla, 11202 SW 59th Place, commented regarding the traffic light at the intersection of Hiatus Road and Stirling Road and asked that a turning signal be added as well as a traffic barrier at the NW corner.

14. COMMISSIONERS' CONCERNS/REPORTS

Commissioner Curran announced that public schools will reopen for the 2011/2012 school year on August 22nd and cautioned drivers to beware of increased school bus and pedestrian traffic; he asked that the hurricane assistance program be publicized to the community and cautioned safe driving awareness for young drivers and their families.

Commissioner Green explained that his position is to represent the best interests of the citizenry of Cooper City and that he carefully educates himself on all of the subject matter that is brought before the Commission as his decisions affect all of the community, including his own family.

Commissioner Sims agreed with the statements of Commissioner Green for his own part, cautioned the Commission against the passing of new laws and commented regarding speeding through the residential streets. He advised that the Commission should find ways to reduce discretionary expenditures.

Commissioner Mallozzi advised that there are many swimming pool and water safety programs available to families with children and suggested that parents ensure that their children learn to swim. She further suggested parents walk their children to school and referenced the "Million Father March" for the first day of school.

Mayor Eisinger addressed the concerns of the residents of Forest Lakes regarding the traffic light at Hiatus and Stirling Roads, the transfer of students to Cooper City schools, and the increased student traffic as school begins on Monday.
