## MINUTES

### **PLEDGE OF ALLEGIANCE**

Mayor Curran opened the meeting at 5:30 PM and led the assembly in the Pledge of Allegiance.

### **ROLL CALL**

Present were Commissioners Smith, Mallozzi, Katzman, Shrouder, and Mayor Curran.

### **PUBLIC COMMENTS**

No public comments.

### **FINANCIAL MATTERS – PUBLIC HEARINGS** | *Fiscal Year 2025/2026 Budget and Taxes*

#### **1. Resolution 25-62 (Finance)**

City Attorney Horowitz read by title "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY ADOPTING A FINAL MILLAGE RATE OF 5.845 FOR GENERAL OPERATING BUDGET PURPOSES FOR FISCAL YEAR 2025-2026; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

City Manager Rey advised that the millage rate of 5.845 represents a reduction from last year's rate and a continuation of the decrease from the past six years.

Commissioner Smith expressed gratitude to the City Manager for listening to the Commission's desire to reduce the millage rate.

Commissioner Katzman thanked the City Manager and the Finance Department. The reduction in the millage over the past six years demonstrates the Commission's dedication to fiscal responsibility.

Commissioner Mallozzi said it's good to know that the Commission is doing its part to help residents as best it can.

Commissioner Shrouder said he believes it may be the seventh year that they have been able to reduce the millage rate.

Mayor Curran supports the reduction, and successfully implementing a reduction over the past seven years is something to be proud of.

Mayor Curran opened the public hearing, but no one wished to speak. He then closed the public hearing.

**MOTION:** Commissioner Smith moved to adopt Resolution 25-62. Commissioner Katzman seconded the motion, which prevailed by a unanimous roll call vote. (5-0)

#### **2. Resolution 25-63 (Finance)**

City Attorney Horowitz read by title” A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, ADOPTING A FINAL BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026, ATTACHED HERETO AS EXHIBIT “A;” DETERMINING AND FIXING THE AMOUNTS NECESSARY TO CARRY ON THE GOVERNMENT OF THE CITY FOR THE ENSUING YEAR; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE” by title.

Commissioner Smith thanked the City Manager for the reduction made since the first hearing. He asked about the concern raised at the First Budget Hearing regarding the funds allocated for art. City Manager Rey said the line should be corrected to Beautification.

Commissioner Katzman stated the line still reads Beautification/Public Art. City Manager Rey will correct the error.

Commissioner Mallozzi spoke about a veteran’s breakfast she attended in the Town of Davie. Several municipalities host this event, which provides vendors with an opportunity to showcase their services to veterans. She would like to include this event in the budget and hold it quarterly. She also discussed the Veterans' Banner initiative, wanting to showcase the banner requests we have received recently. City Manager Rey said that the City can seek sponsorships for the event.

Commissioner Shrouder said the City can cover the cost if she works with staff without directly adding a line item for the event.

City Manager Rey stated that contingency funds are available.

Mayor Curran supports the item and wants staff to focus on the program's needs.

Mayor Curran opened the public hearing, but no one wished to speak. He then closed the public hearing.

**MOTION:** Commissioner Smith moved to adopt Resolution 25-63. Commissioner Shrouder seconded the motion, which prevailed by a unanimous roll call vote. (5-0)
