MINUTES

PLEDGE OF ALLEGIANCE

Mayor Curran opened the meeting at 5:00 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Smith, Mallozzi, Katzman, Shrouder, and Mayor Curran.

TOPIC FOR DISCUSSION

1. Resolution 25-65 - (Administration)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF THE AGREEMENT BETWEEN THE CITY OF COOPER CITY AND THE BROWARD SHERIFF'S OFFICE FOR EMERGENCY MEDICAL, FIRE PROTECTION AND FIRE PREVENTION SERVICES, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING AND DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

City Manager Rey discussed the updates made to the Fire contract so far. If the Commission is agreeable, the Resolutions can be approved. The initial consideration amount was reduced by \$470,000 through negotiation. Two relief positions were eliminated without affecting service. A 6% target is set for year two of the contract, covering the necessary funds for pay raises. It is important to monitor insurance costs and the budgeted allocations. The City will now be responsible for maintaining both safety facilities. Additionally, the contract clearly states that the District Chief position is at the City's sole discretion. The transition period has been extended from 18 to 24 months. All equipment provided by the City to BSO is included in this agreement.

Commissioner Smith asked City Manager Rey if his recommendation is to approve Resolution 25-65. City Manager Rey answered yes.

City Attorney Horowitz stated that some of the language in the agreement may still be subject to change. If the Commission wishes to proceed, he prefers that motions for both items be contingent upon the finalization of the language based on the City Manager's representations. The concepts and substance would only change significantly as described by the City Manager, while the overall form would remain the same.

Commissioner Katzman said he had previously discussed some edits with the City Manager and City Attorney and is comfortable with negotiations. He expressed his gratitude to them, the Public Safety Advisory Board, and the BSO for their hard work. Concerning special events, he asked to include the Autism event held at District 28. Major Christopher De Giovanni advised that regional assets can be made available for the event; however, in the event of an emergency, these assets would be utilized.

Commissioner Shrouder has been involved in BSO negotiations since 2018, and this contract is the most favorable one we've ever signed. He expressed his appreciation to everyone for their hard work and efforts.

Mayor Curran is in favor of the fire contract.

Commissioner Smith made a motion to adopt Resolution 25-65, subject to the finalization of the language of the agreement with the City Manager, City Attorney, along with BSO's command staff, and General Counsel's office. Commissioner Shrouder seconded the motion.

Commissioner Mallozzi stated concerns about ancillary costs. She wants to ensure that the additional funds budgeted for year two are allocated solely for salary adjustments. Major De Giovanni stated that Commissioner Mallozzi's concern has been heard and advised that regular updates and budgeted costs are provided to the City on an annual basis. Commissioner Mallozzi inquired about the \$600,000 allocated for overtime when we have floating positions. Major De Giovanni explained that the City utilizes a 4.3 staffing ratio, which utilizes savings with our staffing complement.

Commissioner Smith confirmed with the ethics office that he is eligible to vote on BSO matters given his profession. City Attorney Horowitz clarified, after speaking with the general counsel from the Florida Commission on Ethics, that there is no voting conflict on either item before the Commission.

MOTION: Commissioner Mallozzi moved to adopt Resolution 25-65, subject to the finalization of the language of the agreement for the City Manager, City Attorney, as well as BSO's command staff and the General Counsel's Office. Commissioner Shrouder seconded the motion, which prevailed by the following roll-call vote. (4-1)

YES: Commissioners Smith, Katzman, Shrouder, and Mayor Curran

NO: Commissioner Mallozzi

2. Resolution 25-66 - (Administration)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF THE AGREEMENT BETWEEN THE CITY OF COOPER CITY AND THE BROWARD SHERIFF'S OFFICE FOR POLICE SERVICES, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; AUTHORIZING AND DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Shrouder inquired about an extra Economic Crimes Deputy. He truly believes no one has aggravated BSO about the contract more than himself. The group that the City has been working with has been the most agreeable and cooperative to date. He thanked BSO staff for their efforts.

City Manager Rey advised that, although there was no reduction to the negotiated amount, BSO has agreed to include Founders Day, Light Up Cooper City, and National Night Out, resulting in savings of nearly \$80,000. BSO was able to reduce the consideration amount in FY25 due to purchasing efficiencies, resulting in a savings of \$94,000. The target amount in year two is 10.5% for the payroll increase. Similar to the Fire side, they have identified positions that will be at the sole discretion of the City. The City will not cover replacement costs for forfeited vehicles. The termination clause is extended to 24 months, and all equipment will be recorded and returned to the City.

City Attorney Horowitz requested that approval be contingent upon finalization of the language as articulated by the City Manager.

Commissioner Katzman thanked City staff, City Attorney Horowitz, and BSO personnel for their work. He wanted to confirm that all his minor edits had been incorporated. City Attorney Horowitz answered yes.

Commissioner Mallozzi inquired about health insurance costs and the differentials for personnel. She also had concerns about the ancillary costs and asked her colleagues to support a forensic audit.

Commissioner Shrouder stated that our contract and state law permit us to obtain data.

City Attorney Horowitz said the Commission can conduct a forensic audit at any time. Additionally, he read Subsection M of Subsection 4 as follows: BSO's Year-To-Date Budget Versus Actual Cost - Line Item Report, which shall include, but not necessarily be limited to, the budgeted amount, expenditures, encumbrances, and remaining balance for each line item within the budget. The City Manager may reasonably request documentation necessary to substantiate any of the costs included on such report, as well as any additional information requested by the Manager.

Commissioner Shrouder is not in favor of the Commission approving an audit of the Sheriff's Office, as it has a negative tone.

Commissioner Smith thanked staff and spoke about the partnership the City has with the Sheriff's Office. He also thanked BSO staff for their work. He also asked for wrapped vehicles to support autism and breast cancer awareness. Major De Giovanni explained that Captain Tianga can wrap vehicles at a cost. Commissioner Smith wants to allocate funds to wrap vehicles.

Commissioner Shrouder suggested wrapping a vehicle used by the Citizens on Patrol (COP). The Town of Davie has a program where the community outreach department handles the wrapping.

Commissioner Smith stated that a forensic audit incurs a significant cost, and he would like to review all details before making a decision. He thanked all BSO staff and expressed his gratitude for their dedication.

Mayor Curran stated that the residents of Cooper City contribute funds to regional assets. Major De Giovanni confirmed that some tax dollars are allocated to Broward County. Mayor Curran inquired about the targeted increase in year two. Major De Giovanni explained that the results from the compensation study will be implemented over a two-year period. City Manager Rey clarified that certain line items are directly related to salaries and benefits. Mayor Curran mentioned there will be a 10% wage increase over the first and second years. Major De Giovanni stated that the exact figures depend on staffing levels in FY 26.

Commissioner Shrouder praised the command staff of BSO for doing a phenomenal job. He does not believe they should discuss forensic audits. He supports staff reviewing numbers but opposes conducting a forensic audit. He wants to be a strong partner.

Commissioner Katzman offered as a compromise that we be more transparent about the budget and actual expenditures.

MOTION: Commissioner Shrouder moved to adopt Resolution 25-66, subject to the finalization of the language of the agreement for the City Manager, City Attorney, as well as BSO's command staff and the General Counsel's Office. Commissioner Katzman seconded the motion, which prevailed by the following roll call vote. (3-2)

YES: Commissioners Smith, Katzman, and Shrouder

NO: Commissioner Mallozzi and Mayor Curran

Colonel Steve Robson thanked City Manager Rey and the Commission and looks forward to continuing an excellent partnership with the City.

ADJOURNMENT

The meeting adjourned at 6:13 PM.
