MINUTES

PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Katzman, Shrouder and Mayor Ross. Commissioners Green and Mallozzi were absent.

PUBLIC COMMENTS (3 MINUTES)

None.

TOPICS FOR DISCUSSION

1. Preliminary Landscape Master Plan

City Manager Alex Rey advised Chen Moore and Associates has been working with staff to develop a landscape master plan. That information will be presented to the Commission tonight with a community workshop being held on July 25th.

Administrative Services Manager Friseta Davis advised tonight's meeting features a comprehensive PowerPoint presentation by Chen Moore and Associates who has been working with the Commission, staff, the Green Advisory Board and other key stakeholders. Through interviews and analysis of 28 sites, rights of ways and intersections the engagement process has gathered valuable insights and 200 responses from residents on various design options. The final master plan is scheduled to be presented in September.

Lance Lilly from Chen Moore and Associates was present along with Tanya McCormick and TeAnna Morgan who were present via Zoom. Mr. Lilly advised they are looking to garner feedback from the Commission regarding the preliminary landscape master plan. The scope for the project was to develop and implement a landscape master plan which will automatically unite the city's open spaces or public spaces and include a selection of streetscapes and landscape identity's for the City. Through that process they will also provide some preliminary or estimated costs for the different concepts as well as strategies for implementation. The process started with information gathering including a public engagement workshop in January. There will be a community workshop held on July 25th with the final master plan being presented in September.

Mayor Ross asked where the 200 responses came from. Communications Director Mike Cobelo explained a survey was sent out through constant contact which is utilized for the City's E-blast. There were a little over 7,000 emails sent out.

Mr. Lilly advised the topics discussed at the January 11th Workshop were branding, visions for the future, signage, landscape, street amenities and potential changes within the City. The survey was open for 30 days to which we received 184 full responses. The preliminary landscape master plan addresses right of ways, intersections and key sites in the City. It also provides some branding options for monument signage, wayfinding, educational traffic signage, outdoor furnishings, lighting, landscape palettes, hardscape architecture and public art. The estimated costs will be provided in the final documents.

Commissioner Katzman has concerns with the costs being provided in September after the budget has been finalized. City Manager Rey explained he plans to allocate funds for the master plan.

Tanya McCormick advised they have started a ranking system for prioritizing.

Mayor Ross said he needs estimated costs to consider what items move forward.

Commissioner Shrouder asked when we started this process. Mr. Lilly answered 2022.

Mayor Ross asked how much we have budgeted so far for the plan and implementation.

Commissioner Shrouder asked why it took two years to see the plan.

Mayor Ross wants to assure no changes can be made after approval from the Commission.

Commissioner Shrouder asked why the process took two years. Mr. Lily said there was a change in staff and there was a divine design impact. Commissioner Shrouder does not see much change from the plan presented at the workshop.

City Manager Rey said \$400,000 dollars has been budgeted this year. Any remaining funds will move forward in the next fiscal year.

Mr. Lilly said they evaluated 28 sites and ranked items based on priority. He provided monument signage options to the Commission. The stone with architectural columns received 62 responses with the natural stone with metalwork receiving 65 responses.

Commissioner Shrouder asked if stone with architectural columns is modern or traditional. Mr. Lilly responded traditional.

Commissioner Katzman asked if natural stone is modern.

Ms. McCormick explained option one is described as a modern design with stone metal accents and clean finishes. Option two is more of a traditional design with the stack stone and wood accents that would match the City's current monument sign.

Mayor Ross would like the responses listed in order on page 39 of the plan presentation.

Commissioner Shrouder said he would like Chen Moore and Associates to present two options citing the one favored by the residents.

Ms. McCormick is trying to gather information on what the Commission is in favor of for design. Options can be achieved with different materials that are less costly.

Mr. Lilly said the trend for the responses was more for a modern look. They also wanted to provide a traditional look to be considered as well.

Commissioner Katzman said the survey garnered a small response. He would like two options presented at the next public workshop so the Commission can make a decision based on responses from the workshop. He also wants options to stay consistent with regard to modern and traditional.

Mayor Ross wants to see the options based on the lower cost selections as described. Mayor Ross also spoke on less landscape options to save on maintenance costs.

Mr. Lilly said they included Florida native options and low maintenance options.

Commissioner Shrouder wants options provided.

Ms. McCormick said the full plan tonight was not intended to be presented to the public. They would like options chosen tonight that then can then be provided to the residents.

Commissioner Katzman would like the residents to have serious input.

Commissioner Shrouder likes option one.

Mr. Lilly addressed signage with wayfinding, educational and traffic options.

City Manager Rey said most cities are moving away from wayfinding signs.

Commissioner Shrouder said he believes they can mix and match.

Commissioner Katzman said removing rocks from the bottom of the signs may help with cost.

Mr. Lilly said the options can be tailored.

Mr. Lilly also spoke on site and outdoor furnishings.

Commissioner Katzman said the modern option is appealing to him but he wants the resident's feedback.

Mr. Lilly also spoke on the landscape palette options.

Mayor Ross asked that the font on the presentation be adjusted for easier viewing.

Mr. Lilly said some areas might not be able to accommodate large trees. What would the Commission like to see in some of those areas that cannot fit the large trees. Would it be small accent trees or would it be some type of palms.

Ms. McCormick said the options are really a full native Florida palette which is a low water use. Or option two which is your ornamental plant palette, which is higher water use and higher level maintenance.

Commissioner Shrouder prefers the ornamental.

Commissioner Katzman agrees with ornamental but asked how much more maintenance costs it would entail.

The Commission supports option two.

Mr. Lilly next spoke on hardscapes.

Commissioner Shrouder said the hardscape options will be based on the budget as he prefers option two but it looks to be more costly.

Mayor Ross prefers option two.

City Manager Rey stated the raised pavement and colors tend to lower speeding as well.

Mr. Lilly spoke on architecture and the modern and traditional options.

Commissioner Shrouder likes option two.

Mayor Ross and Commissioner Katzman prefer option one.

Mr. Lily spoke on the public art options.

Commissioner Katzman would like ideas on wrapping the utility boxes.

City Manager Rey said he is working with City Attorney Horowitz to draft an agreement to wrap the utility boxes.

Commissioner Katzman asked that we expedite the process. He also recommended asking the Green Advisory Board to work on the matter.

City Manager Rey said he has in the past held local artist competitions.

Commissioner Shrouder also spoke on the windscreen being up at the Sports Complex. He advised staff placed windscreens at the sports complex due to complaints.

Commissioner Katzman wants the windscreen removed as staff should not violate the city ordinance.

Commissioner Shrouder also spoke on the Season's Greetings signs that were purchased but not placed out last year due to staff citing a resident's complaint.

Commissioner Katzman asked that the survey options be placed online and printed versions in City facilities to gather as much feedback as possible.

Commissioner Shrouder would like pictures and prices.

ADDITIONAL PUBLIC COMMENTS (3 MINUTES)

A resident suggested perhaps removing the pots to reduce maintenance on the monument sign presented.

Commissioner Shrouder also asked for uniform option looks on Palm Avenue. Commissioner Shrouder would also like to update all the City logos.

Mayor Ross thanked Chen Moore and Associates.

ADJOURNMENT

The meeting adjourned at 7:30 PM.
