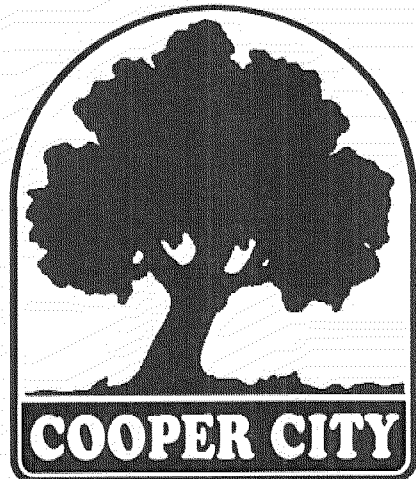

PUBLIC PARTICIPATION AT CITY COMMISSION MEETINGS

The Mayor and City Commissioners, as your elected officials, welcome you to air your viewpoints about any item of concern to you. So that the City Commission may do its best to complete the business of the City at each meeting, they have set aside a half hour at the beginning of the meeting (Agenda Concerns) for public comment, but must limit individual remarks to three (3) minutes in order to accommodate as many residents as possible. Comments during this time may only address any issue on the current agenda, provided that if a person wishes to speak on an item designated for public hearing, their comments should be held until the public hearing is opened by the Mayor.

At the designated time of 8:30 p.m. during the regular Commission meeting, the Open Public Meeting portion shall be conducted for a time period of 30 minutes, during which time period any individual may speak for up to 3 minutes on any matter(s) which are pertinent to the City (whether or not the matter(s) pertains to any item that is listed on the meeting agenda). In the event that the meeting would adjourn prior to the 8:30 p.m. time slot scheduled for the Open Public Meeting portion, the Open Public Meeting portion shall be held prior to the adjournment of the Commission meeting. Other than an announcement of candidacy, public speaking times shall not be used to make political statements for or against candidates or election issues. Members of the Commission, staff members, citizens and others are required to use civil and appropriate language when addressing the Commission or anyone present at the meeting, and must refrain from using profanity, cursing, or exhibiting aggressive or threatening behavior. All comments should generally be directed to the presiding officer and not to individual members of the Commission, staff or the audience. No personal verbal attacks toward any individual by either the Commission, staff, citizens or others shall be allowed during any meeting of the Commission.

Any persons making impertinent or slanderous remarks or personal attacks or who becomes boisterous while addressing the Commission or who violates the rules of decorum shall be barred from further audience before the Commission by the Chair or by request of any member of the Commission, unless permission to continue or again address the Commission be granted by the majority vote of the Commission members present.

Pursuant to Florida Statute 286.0105, if a person decides to appeal any decision made by the body with respect to any matter considered at such meeting or hearing, they will need a record of the proceedings, and for such purpose, they may need to ensure that a verbatim record of the proceedings is made, which record includes testimony and evidence upon which the appeal is to be based.

Matt Wood read the staff report relative to the petitions and the plat note amendment, including stipulations and additional conditions for approval.

Atty. for the petitioner, Debby Orshefsky presented the petitions, including stipulations and amendments, requested approval of the Commission and responded to questions.

Theresa Sansone, 2598 Garden Court, spoke in support of the approval of the petitions and asked for traffic calming measures to be stipulations of the approval.

Steve Mason, 11425 Wayne Drive, expressed traffic impact concerns, requesting right turn only access in and out of the campus.

David McKennan, 12205 Paseo Way, spoke in opposition of the petition, citing traffic concerns as and taxable revenue concerns.

Susan Kerns, 12105 Paseo Way, spoke in opposition to the approval of the petitions, citing traffic concerns and requesting a sound barrier wall be place along the roadway and other traffic diversion devices be required as stipulations for approval.

Barbara Epstein, 12006 Landing Way, spoke on support of traffic mitigating and diverting stipulations for approval of the petitions.

John Heggy, 3901 Limestone Drive, reiterated previously expressed traffic concerns regarding using the Rock Creek community roads as a shortcut to the proposed charter school.

Unanimous consensus was reached to conclude the Land Development Matters portion of the Agenda prior to proceeding to Open Public Meeting.

Fran Adler, 4103 East Sailboat Drive, reiterated traffic concerns.

Diana Koch, 68 Forest Circle, expressed opposition to the petitions based on traffic issues.

Pat Wahl, 11613 Sunfish Wahl, spoke in support of the petitions, only if traffic would be diverted from the Rock Creek community and made some traffic diversion recommendations.

Carline Kiracofe, 3500 Bark Way, expressed opposition to the petitions based on increased traffic concerns.

Mike Riley, Limestone Drive, echoed the sentiments of those concerned by the increased traffic potential.

Yvette Diaz Rubio, Limestone Drive, expressed the need for a traffic light and for traffic diversion.

Tiffany Mosca, 3601 Bridge Road, expressed support for the petitions, with additional traffic calming measures.

Rosa Counts, Rock Creek Resident (oath administered at this time), echoed the sentiments of those who oppose the petitions based on the lack of traffic mitigation or diversion devices.

Edwina Lindeman, 47 Birch Drive, (oath administered at this time) expressed the need for traffic diversion devices.

Gary Laufenberg, P & Z Board member (oath administered at this time), supported the concerns of residents regarding traffic and explained that he voted no to the project for this reason.

Linda Gardner, Rock Creek resident (oath administered at this time), echoed traffic concerns.

Michael Payne, Rock Creek resident (oath administered at this time), stressed that the petitioner should go to any level they can to have the traffic issues mitigated.

Tom Palink, Rock Creek resident (oath administered at this time), expressed pedestrian safety concerns.

Unanimous consensus was reached to extend the meeting time to allow for the completion of the item.

Several unidentified residents asked questions regarding traffic plans and traffic calming devices.

David McKennan, 12205 Paseo Way, questioned the City's policy regarding payment for traffic calming devices and offered financing suggestions.
