# MINUTES

## PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 5:30 PM and led the assembly in the Pledge of Allegiance.

## ROLL CALL

Present were Commissioners Shrouder, Meltzer, Pulcini, Green and Mayor Ross.

## **TOPICS FOR DISCUSSION**

## FY 2023 Overview

City Manager Napoli advised the Public Input Meeting required by Charter was held on May 10, 2022. Staff is in the process of formulating the FY 2023 budget. A few areas of concerns surrounding the FY 2023 budget is the residual impacts of Covid, inflation and a possible recession.

CFO Aaron Kendrick advised the May 10, 2022 Public Input Meeting resulted in no comments. In FY 2021 the governmental fund had \$40 million in expenditures. In FY 2021 we had \$59 million in total expenditures, FY 2022 anticipates \$72 million in expenditures. The cost differential is related to ARPA funds. The FY 2023 budget assumes an undetermined millage rate. The Revitalization and Beautification initiative remains a top priority. Potential staffing changes include an additional Treatment Plant Operator, Mechanic 1 in Utilities and a Capital Project Coordinator funded by ARPA. With inflation at a 40 year high, staff is assuming a merit and COLA increase to remain competitive among neighboring municipalities. Staff is assuming a 5% increase in electricity due to fuel costs. The water and sewer rates based on the annual CPI will be moving to 8.5%. Postage rates will be increased by approximately 10%. There are also potential increase with new contracts and construction materials due to inflation. The potential resurgence or residual impacts of Covid-19 continues to be a concern. A BSO consideration increase, inflationary pressures, collective bargaining impacts, non-recurring ARPA dollars and healthcare cost increases all continue to be concerns.

Commissioner Shrouder asked if we know what the increase in ad valorem property tax would be assuming the same millage rate. CFO Kendrick answered that information is released the first week of June.

Commissioner Meltzer wants to assure any funds allocate to the Revitalization and Beautification initiative are rolled forward to FY 2023. He also asked staff to remain mindful of budget expenses with rising inflation. He also wants to assure we budget appropriately for traffic calming. We also need to have savings for the Capital Improvement Plan especially for turf for Flamingo West Park. He wants to assure we are receiving our fair share of governmental revenues and utilizing and applying for all grants available. He spoke on a 5% increase potentially for BSO and healthcare costs. He also asked if there are any rates that may need to be looked at. City Manager Napoli advised we will reexamine storm water rates. He would also like to have a Tree Workshop to address tree roots issues.

Commissioner Green wants to assure we budget to address staffing retention and levels.

Commissioner Pulcini agrees with Commissioner Green on the importance of employee retention. He would like to stay cognitive of pension liability moving forward with negative returns. He would also like move ARPA funds out of fund balance. CFO Kendrick advised they are in fund balance as they are anticipated to be spent. Commissioner Pulcini advised we are budgeting without the audit. CFO Kendrick advised the audit is expected to be finalized within the next few weeks.

Mayor Ross said with proposed Ordinance 22-13 we are looking to add an additional sum of money to the fund balance requirement. He advised it is incumbent to listen to each other and look at solutions.

Commissioner Pulcini advised we ended last year with \$41 million in fund balance and regardless of what ordinance we pass he does not see the \$3 million dollars that the Commission designated as committed on the financials. CFO Kendrick answered those funds are committed but not listed as a separate line item on the financials.

Commissioner Meltzer advised it should be on the balance sheet as committed. CFO Kendrick will take list the funds as such.

Commissioner Pulcini asked if sidewalk repairs are currently budgeted for. CFO Kendrick answered yes.

## **ADDITIONAL PUBLIC COMMENTS (2 MINUTES)**

Ileana Ryan, 9461 SW 49 Place, spoke on moving to Cooper City because of the Tree City designation and she would like more trees planted in the City to keep tree canopies.

Commissioner Pulcini advised we have a Tree Trust Fund.

Commissioner Meltzer advised we also have a Revitalization and Beautification initiative to address tree planting. He also said some tree removal is due to sidewalk issues.

Ms. Ryan would like to update the trees that are allowed to be planted in the City.

## **ADJOURNMENT**

The meeting adjourned at 6:15 PM.
