This report will follow the same flow of my prior reports, which is aimed at highlighting information pertinent to the city's main public safety concerns: Fire Rescue Incidents, Fire Prevention, Community Outreach, Fire Apparatus/Station, and CERT.

III. Community Outreach Report

- a. On June 17th, Engine 28 along with BSO's Life Safety Educators provided a static display and orientation to 75 students at Franklin Academy ages 5-10 and grade range of K-5th.
- b. On June 17th, Station 28 crews along with BSO's Life Safety Educators conducted a station tour for Nee's Kung Fu summer program which was attended by 20 campers ages 5-12.
- c. On June 18th, Rescue 228 attended a Father/Son Fishing Tournament located at the Pool and Tennis Center Park.
- d. Upcoming community outreach events include Eat to the Beat, National Night Out, Christian Academy Summer Camp, and Autism Awareness

IV. Fire Apparatus/Station Report

- a. On June 21st, City Fire inspected and tested the fire alarm systems in the DLE building along with Fire Station 28.
- b. On June 23rd, Rescue 28 and Rescue 228 will be inspected by the assessors from the Commission on Accreditation of Ambulance Services (CAAS). This inspection will consist of vehicle certifications, equipment, personnel licenses, and Standard Operating Procedure knowledge along with inherent knowledge, skills and assessments of Medical Protocols.
- c. Proposals for the 75'Quint, Engine and Rescue have been received from Pierce; however, we are still waiting on proposals from E-One.
- d. Station 28 crews are continuing hydrant testing to meet this year's deadline and for Insurance Services Office (ISO) requirements. To date: 897 hydrants have been tested with 333 pending for a total of 1230 hydrants

V. Community Emergency Response Team (CERT)

a. On June 23rd, CERT will be participating in a tactical scenario called Operation Nightingale taking place at FLL airport.
