Hello Alex: Hope all is well on your end.

The deputies and firefighters have not yet received the raises.

BSO intends to provide the raises to all deputies and firefighters across the agency retroactively back to October 1<sup>st</sup> (as we have done on several occasions in the past) as soon as our appeal to the Administrative Commission is completed. In the unlikely event that BSO does not prevail in our appeal, or if the Administrative Commission authorizes an amount less than what BSO is appealing, we will then reevaluate the situation and determine how to best proceed.

Should BSO for any reason not provide the raises or provide the raises in a lesser amount than what was negotiated with Cooper City, BSO would work with Cooper City to adjust the consideration in the same manner as BSO worked to adjust the consideration for FY25 when we did not purchase public safety radios and credited that amount back to Cooper City.
