Mayor Ross opened the meeting at 5:31 PM and led the assembly in the Pledge of Allegiance.

# **Open Public Meeting**

Carmen Muir, 11315 Lake Shore Drive, spoke on expanding the pickle ball courts.

Juan Lorenzo, spoke on parents dropping off children in front of his home in Country Address.

Ana Harding, also spoke on parents dropping off children near her home.

Commissioner Shrouder said they recently increased the amount of the citation from \$25 to \$100 and said officers do record cars in violation and mail citations.

Captain DeGiovanni said staff issues hundreds of traffic citations tied to the schools. Deputies do patrol Country Address and issue citations.

Catherine Martinez, 12237 SW 50 Street, spoke on behalf of the volleyball league and spoke in support of keeping the sand volleyball courts and possibly expanding.

FINANCIAL MATTERS – PUBLIC HEARINGS | Fiscal Year 2024/2025 Budget and Taxes

#### 1. Resolution 24-31 (Finance)

City Attorney Horowitz "A RESOLUTION OF THE CITY OF COOPER CITY, FLORIDA, RELATING TO THE PROVISION OF FIRE SERVICES, FACILITIES AND PROGRAMS IN THE CITY OF COOPER CITY, FLORIDA; ESTABLISHING THE RATE OF ASSESSMENT; IMPOSING FIRE ASSESSMENTS AGAINST ASSESSED PROPERTY LOCATED WITHIN THE CITY OF COOPER CITY; APPROVING THE ASSESSMENT ROLL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Green wants to confirm this does not have any financial impact on tax exempt, nonprofit organizations. City Attorney Horowitz answered it does not.

Commissioner Katzman asked CFO Irwin Williams to explain why the increase is being proposed. CFO Williams explained the costs are being raised to 100% to cover the cost of the fire department. In the past the money has come from the general fund to fund the additional costs. Commissioner Katzman said the purpose is to ensure that anyone using the fire services, including nonresidents and business owners would be paying their fair share versus the residents' solely taking on the costs. CFO Williams confirmed the cost will now be spread to all users.

Mayor Ross opened the public hearing.

Ana Harding asked where a fire station is being built.

Mayor Ross clarified the current station is being rebuilt or repaired.

Mayor Ross closed the public hearing.

### 2. Resolution 24-32 (Finance)

City Attorney Horowitz "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY ADOPTING A TENTATIVE MILLAGE RATE OF 5.865 FOR GENERAL OPERATING BUDGET PURPOSES FOR FISCAL YEAR 2024-2025; PROVIDING FOR THE ESTABLISHMENT OF AND SETTING FORTH THE DATE, TIME AND LOCATION OF THE PUBLIC HEARING TO FORMALLY ADOPT THE FY 2024-2025 MILLAGE RATE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

City Attorney Horowitz advised the tentative millage rate of 5.865 for general fund budget purposes for the upcoming fiscal year represents a 7.34% increase over the rollback rate of 5.4637 mills and it is statutorily required that the rollback rate and percentage be read into the record.

Mayor Ross asked the 5.865 compared to last year. CFO Williams answered it is the same rate as last year.

Commissioner Shrouder moved to approve a millage rate of 5.855.

Commissioner Green seconded the motion.

Commissioner Shrouder would like to lower the tax rate for the fifth year in a row.

Commissioner Green asked CFO Williams if he is okay with a rate of 5.855. CFO Williams answered yes.

Commissioner Katzman said he supports lowering the millage and suggested the lower amount previously. He asked if he still had support for the \$300,000 funding for playground renovations as directed at a previous meeting. CFO Williams will make sure the \$300,000 is in the budget

Commissioner Mallozzi does not want to piecemeal items when they have a Parks and Recreation Master Plan that will determine what needs to be done.

Commissioner Katzman said he is simply allocating funds to be used when the feedback is received from the study.

Commissioner Mallozzi said the budget can be adjusted at any time.

Mayor Ross said he would like the park renovations to include handicap accessible equipment. He wants the meeting tonight to be forwarded to the planners for the Parks and Recreation Plan.

Budget Analyst Mike Nadeau advised we had \$400,000 budgeted for FY 24 park renovations that was not used and can be rolled over.

Mayor Ross opened the public hearing.

Ana Harding asked what park will be renovated.

Commissioner Katzman said the City is currently doing a Parks and Recreation Plan and his goal is to assure some funds are saved. Ms. Harding spoke on concerns at the park near her home with the rock climbing wall and advised she called Parks and Recreation numerous times.

Commissioner Mallozzi said some park equipment is age related.

Commissioner Shrouder asked CFO Williams to follow up on why Ms. Harding's concerns were not addressed by the Parks and Recreation Department.

Mayor Ross closed the public hearing.

**MOTION:** Commissioner Shrouder moved to reduce the millage rate to 5.855. Commissioner Green seconded the motion which prevailed by a unanimous roll call vote. (5-0)

**MOTION:** Commissioner Shrouder moved to approve Resolution 24-32 as amended. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

### 3. Resolution 24-33 (Finance)

City Attorney Horowitz "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, ADOPTING A TENTATIVE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30, 2025, ATTACHED HERETO AS EXHIBIT "A;" DETERMINING AND FIXING THE AMOUNTS NECESSARY TO CARRY ON THE GOVERNMENT OF THE CITY FOR THE ENSUING YEAR; DETERMINING THE AMOUNT OF APPLICABLE FUNDS ON HAND; ESTIMATING RECEIPTS AND EXPENDITURES FOR ALL FUNDS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Shrouder asked if revisions can be done at the second and final hearing. City Attorney Horowitz answered yes.

Commissioner Katzman advised the structure is not accurate. CFO Williams understands the organizational charts need adjusted but said the numbers are the final numbers.

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.
