Subject: Fire Chief's Report - Commission Meeting September 24, 2024

The following is the Fire Chief's report for the upcoming commission meeting. The report highlights information pertinent to the city's main public safety concerns: Fire Rescue Incidents, Fire Apparatus / Station concerns, Fire Prevention, Community Outreach, and CERT.

Longest Response Time: 13:11 min. Average Response Time: 05:15 min.

The longest emergent response was 13 minutes and 11 seconds which occurred due to a minor mechanical issue that was addressed. There was another outlier delay of 12 minutes and 32 seconds. The cause of the delay was traffic and distance to the incident (eastern edge of Monterra). The last response time outlier of 9 minutes and 29 seconds was due to the distance to the incident (west area of Country Glen).




IV. COMMUNITY OUTREACH REPORT

- August 1, 2024, Life Safety Educators, District Chief Brown, Division Chief Gabay, and Chief Harrington participated in the "Breakfast with the Principles" to strengthen relationships with the local school principles.
- August 7, 2024 Life Safety Educators and the fire fighters on Engine 28, provided fire safety education to 60+ people at Schott Communities.
- August 9, 2024, Life Safety Educators along with the crew of Engine 28, participated in Cooper City's National Night Out (500+).
- Car Seat instruction and installation were performed by BSO Life Safety Educators for residents on multiple dates throughout the month of August.
- CERT held a meeting on August 29th to discuss, plan and schedule for the upcoming CERT Basic Training Class. An announcement will be forthcoming on dates, times and location.
- Fire Station 28 tour and 9/11 Tribute was presented to the firefighters at Fire Station 28 by Embassy Creek Elementary students, teachers and parent-chaperons on September 11th. The students, parents and teachers were provided a station tour and truck demonstration.
- The crew of Rescue 28 were presented a plaque on September 11th, in recognition of life saving actions regarding the treatment and transport of a patient.
- District Chief Brown participated in a 9/11 remembrance ceremony at Cooper City High School.
