

FIRST AMENDMENT TO AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF COOPER CITY FOR DESIGN, CONSTRUCTION, AND MAINTENANCE OF BUS STOP IMPROVEMENTS

This is the First Amendment to the Agreement (the "First Amendment") between Broward County (the "County") and the City of Cooper City, a municipal corporation located in Broward County, Florida, organized and existing under the laws of the state of Florida (the "Municipality") (collectively the "Parties").

RECITALS

- A. The Parties entered into an Agreement dated April 7, 2015 ("Agreement"), which provided for the installation and maintenance of bus stop improvements within the jurisdictional limits of the Municipality.
- B. The Parties desire to enter into this First Amendment to provide for bus stop improvements at fourteen (14) additional locations.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

- Except as expressly modified herein, all terms and conditions of the Agreement remain in full force and effect. Amendments made to the Agreement by this First Amendment are indicated by use of strikethroughs to indicate deletions and underlining to indicate additions. Terms used herein but not defined herein shall have the meanings ascribed to such terms in the Agreement.
- 2. Article 2 of the Agreement, titled "Scope of Participation," is amended to read as follows:
 - 2.1.1 Prepare, or cause to be prepared, plans for <u>and installation of</u> Bus Stop Improvements for the Property. Such plans shall be reviewed and approved by MUNICIPALITY's Contract Administrator.

- 2.1.4 <u>Upon completion of the installation, turn the Bus Stop Improvements over to the Municipality and Pprovide signed and sealed certified as-built drawings detailing the pertinent information regarding the installation, per the Plans, prior to requesting a final inspection from Contract Administrator.</u>
- 3. Exhibit A is hereby replaced with the attached amended Exhibit A.
- 4. The effective date of this First Amendment shall be the date of complete execution by both Parties. This First Amendment represents the final and complete understanding of the Parties regarding the subject matter of the items addressed herein, and together with the remainder of the Agreement, supersedes all prior and contemporaneous negotiations and discussions regarding that subject matter. There is no commitment, agreement, or understanding concerning the subject matter of this First Amendment that is not contained in this written document or the Agreement.
- 5. This First Amendment may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.
- 6. Each individual executing this First Amendment on behalf of a party hereto hereby represents and warrants that he or she is, on the date he or she signs this First Amendment, duly authorized by all necessary and appropriate action to execute this First Amendment on behalf of such party and does so with full legal authority.

STOP # 4700

Improvements for Stop ID #4700 are to be located within the southerly right-of-way of Stirling Road and lying easterly of NW 90th Avenue, of DIAMOND HEAD PLAT, according to the plat thereof as recorded in Plat Book 155, Page 24, of the Public Records of Broward County, Florida, Bounded as follows:

Bounded on the West by a line 100 feet easterly of the existing east right-of-way line of said NW 90th Avenue and bounded on the East by a line 114 feet easterly of said east right-of-way line of NW 90th Avenue, all as measured along the existing southerly right-of-way line of Stirling Road.

Said lands lying in Cooper City, Broward County, Florida.

STOP # 4699

Improvements for Stop ID #4699 are to be located within the northerly right-of-way of Stirling Road and lying westerly of NW 90TH Avenue, of COOPER CITY CHURCH OF GOD PLAT, according to the plat thereof as recorded in Plat Book 152, Page 35, of the Public Records of Broward County, Florida. Site address: 9191 Stirling Road, Cooper City Florida, 33331, according to Property Appraiser's office. Bounded as follows:

Bounded on the East by a line 120 feet westerly of the existing west right-of-way line of said NW 90TH Avenue and bounded on the West by a line 134 feet westerly of said west right-of-way line of NW 90TH Avenue, all as measured along the existing northerly right-of-way line of Stirling Road.

Said lands lying in the Cooper City, Broward County, Florida.

STOP #4692

Improvements for Stop ID #4692 are to be located within the southerly right-of-way of Stirling Road and lying easterly of Flamingo Road, of STONEBRIDGE PHASE 1, according to the plat thereof as recorded in Plat Book 91, Page 9, of the Public Records of Broward County, Florida. Bounded as follows:

Bounded on the West by a line 115 feet easterly of the existing east right-of-way line of said Flamingo Road and bounded on the East by a line 129 feet easterly of said east right-of-way line of Flamingo Road, all as measured along the existing southerly right-of-way line of Stirling Road.

Said lands lying in the Cooper City, Broward County, Florida.

STOP #4694

Improvements for Stop ID #4694 are to be located within the southerly right-of-way of Stirling Road and lying easterly of Hiatus Road, of EMBASSY LAKES PHASE II, according to the plat thereof as recorded in Plat Book 141, Page 4, of the Public Records of Broward County, Florida. Bounded as follows:

Bounded on the West by a line 185 feet easterly of the existing east right-of-way line of said Hiatus Road and bounded on the East by a line 199 feet easterly of said east right-of-way line of Hiatus Road, all as measured along the existing southerly right-of-way line of Stirling Road.

Said lands lying in the Cooper City, Broward County, Florida.

STOP #4693

Improvements for stop ID #4693 are to be located within the northerly right-of-way of Stirling Road and lying westerly of Hiatus Road, of RESUBDIVISION OF TRACT "D" – FOREST LAKE, according to the plat thereof as recorded in Plat Book 155, Page 45, of the Public Records of Broward County, Florida. Bounded as follows:

Bounded on the east by a line 130 feet westerly of the existing west right-of-way line of said Hiatus Road and bounded on the west by a line 150 feet westerly of said west right-of-way line of Hiatus Road, all as measured along the existing northerly right-of-way line of Stirling Road.

Said lands lying in Cooper City, Broward County, Florida.

STOP #4695

Improvements for stop ID #4695 are to be located within the southerly right-of-way of Stirling Road and lying westerly of Palm Avenue, of COOPER CITY MUNICIPAL FACILITY, according to the plat thereof as recorded in Plat Book 140, Page 32, Parcel "A" of the Public Records of Broward County, Florida. Bounded as follows:

Bounded on the east by a line 830 feet westerly of the existing west right-of-way line of said Palm Avenue and bounded on the west by a line 850 feet westerly of said west right-of-way line of Palm Avenue, all as measured along the existing southerly right-of-way line of Stirling Road.

Said lands lying in Cooper City, Broward County, Florida.

STOP #6001

Improvements for stop ID #6001 are to be located within the southerly right-of-way of Stirling Road and lying westerly of SW 112th Avenue, of ROCK CREEK PHASE TWO, TRACT "E", according to the plat thereof as recorded in Plat Book 104, Page 34, of the Public Records of Broward County, Florida. Bounded as follows:

Bounded on the east by a line 940 feet westerly of the existing west right-of-way line of said SW 112th Avenue and bounded on the west by a line 960 feet westerly of said west right-of-way line of SW 112th Avenue, all as measured along the existing northerly right-of-way line of Stirling Road.

Said lands lying in Cooper City, Broward County, Florida.

STOP #6068

Improvements for stop ID #6068 are to be located within the westerly right-of-way of University Drive and lying southerly of Stirling Road, of MONTERRA PLAT, PARCEL "C-1", according to the plat thereof as recorded in Plat Book 175, Page 159, of the Public Records of Broward County, Florida. Bounded as follows:

Bounded on the north by a line 216 feet southerly of the existing south right-of-way line of said Stirling Road and bounded on the south by a line 246 feet southerly of said south right-of-way line of Stirling Road all as measured along the existing westerly right-of-way line of University Drive.
