TITLE: Resolution No. 24-03 (Utilities Department)

DATE: March 12, 2024

DESCRIPTION: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY,

FLORIDA, APPROVING AND AUTHORIZING THE AMENDMENT TO THE GRANT AGREEMENT NO. LPA0155 WITH THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION FOR THE SW 49th STREET CULVERT REHABILITATION/REPLACEMENT, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; PROVIDING FOR CONFLICTS; PROVIDING FOR; AND

PROVIDING AN EFFECTIVE DATE.

CITY MANAGER RECOMMENDATION:

The City Manager Recommends approval of Resolution 24-03, to approve and authorize execution of an amendment to the grant agreement No. LPA0155 with the Florida Department of Environmental Protection to rehabilitate or replace the SW 49th Street Culvert.

BACKGROUND OF ITEM:

On September 2021, the City Commission adopted Resolution No. 21-40 approving and authorizing a grant agreement with the State of Florida Department of Environmental Protection for the SW 49th Street Culvert Rehabilitation or Replacement project in the amount of \$125,000. However, as the Project was evaluated further, it became apparent that additional funding may be required due to companion improvements associated with culvert replacement.

ANALYSIS:

On February 2023, the City requested additional grant funding in the amount of \$450,000 from the Florida Legislature/FDEP. The additional funding was approved, so an amendment to the grant agreement No. LPA0155 is required to provide additional time to complete the project. The total funding for this agreement is now \$575.000.

FISCAL IMPACT:

This proposed amendment provides for additional funding from the State in the amount of \$450,000 toward the repair or replacement of the culvert.
