MINUTES

PLEDGE OF ALLEGIANCE

Mayor Ross opened the meeting at 2:30 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Katzman, Shrouder and Mayor Ross. Commissioners Mallozzi and Green were absent.

PUBLIC COMMMENTS (3 MINUTES)

Carmen Muir, 11315 Lake Shore Drive, thanked the Commission and staff for the improvements made for pickle ball.

TOPICS FOR DISCUSSION

1. FY25 Requested Budget

City Manager Alex Rey thanked the Public Works Department for their hard work on the pickle ball enhancements. He advised the proposed millage rate is the same as last year at 5.8650. The property values in the City continue to increase. A task in the strategic plan was to increase revenue with investments and earned interest. Currently the City is looking to upgrade or replace the Fire Station. In order to start the project we need to collect 100% or close to 100% of the Fire Assessment fee. Personnel costs are increasing by 13.8% due to the compensation study. Additional positions include a Grant Administrator, three part time positions in Parks and Recreation for adult programs, park attendant, lifeguard, a plant operator 1 and the electrician assistant moving from part-time to full-time. Property insurance will rise 3%, auto insurance is up 15% and workman's comp is up 10%. There are also new capital improvements for the pickle ball courts included in the budget at \$100,000. Reconfiguring the courts will cost approximately \$25,000 for each court. The \$100,000 will cover design and engineering plans when we receive the Parks and Recreation Master Plan.

Mayor Ross asked if the tennis pro we contract with has weighed in on the potential court changes. City Manager Rey answered yes he is currently in negotiations to amend the contract.

Commissioner Katzman asked if the contractor is using the tennis courts currently. City Manager Rey said the court changes will be temporary. Commissioner Katzman asked about the changes to the insurance costs. City Manager Rey said initially the Gehring Group gave the City the wrong information. Commissioner Katzman asked if the City needs an agent of record. City Manager Rey said he will look into all options.

Mayor Ross asked what we pay the Gehring Group. City Manager Rey will look into the costs.

City Manager Rey advised he is also requesting improvements to the public safety complex. He would like to move forward on plans and design to present the project in Tallahassee.

Mayor Ross said under Chief Caruso a plan was completed by BSO.

City Manager Rey would also like to look into a new Public Works compound and allocate funds to a long term plan. The Landscape Beautification plan is also proposed in the budget. He would also like to update the access system into City facilities. He is proposing allocating a contingency amount of \$400,000 dollars to be used for matching funds consistent with the creation of a new grant writer position. He would like to transfer risk management responsibilities to the Finance Department as opposed to Human Resources. He is requesting additional funds for tree trimming to supplement City crews for FY 25 for one year to catch up on tree maintenance in the City. He is also looking to implement a storm water fee increase of 15.28% for FY 25 to keep up with inflation and the development of a Stormwater Master Plan.

Commissioner Katzman said we need to include the Royal Palm Ranches area when looking into storm water enhancements. City Manager Rey said they need to work out the issue of the private roads within the Royal Palm community. Commissioner Katzman said there are new State regulations regarding sewer.

Commissioner Shrouder said they need to coordinate the sewer and road pavements.

Interim Public Works Director Dave Harvell spoke on a potential merger of the Public Works Department and the Utilities Department. Interim Director Harvell said the merger of Public Works and Utilities will create a more effective organization including growth within. The combination of the departments will create a better organizational culture. The administration staff can be consolidated and park maintenance can be transferred to Parks and Recreation.

Mayor Ross asked if the Directors support the merger. Interim Director Harvell answered yes.

City Manager Rey explained the proposed organizational chart. He also spoke on a restructure of the Parks and Recreation Department. The current budget does not include the proposed organizational chart as he did not want to be presumptuous.

Commissioner Katzman asked if there will be any monetary impacts in the proposed changes. City Manager Rey said there will be no additional costs. There will be some small savings.

Commissioner Shrouder asked how long the reorganization would take. City Manager Rey answered 30 days.

Utilities Director Tim Welch spoke on the metering infrastructure. The City has about 11,900 metered water connections. About 6,690 were replaced by advanced metering infrastructure. Advanced meters include 1,170 manually encoded registers and 5,520 solid state registers. There are also 5,210 additional manual read meters of various manufacturers. There are many challenges currently with the meters including reading and transmission failures. Director Welch believes we have three options available. Option one, a manual meter process. Option two, replacing failing Mueller system meters with a phased delivery of working AMI products until a whole system is converted. Option three, replacing the Mueller sets with total AMI replacement. Numerous utilities have successfully converted to AMI. The benefits of AMI are real time notifications, remote meter capability, improved billing and payment processing and accuracy. A manual meter conversion would cost roughly \$1,318,639 dollars. A phased AMI system would cost \$2,980,123 dollars. If the Commission supported the recommended option of the AMI system he would request approval to stock 200 Senusus iPERL meters to replace new failures.

City Attorney Horowitz advised the City has two agreements with Mueller and spoke on opportunities for the City regarding claims and the need for a bill of discovery to speak to previous staff.

Commissioner Katzman asked when the previous agreements were approved. City Attorney Horowitz answered 2017 and 2021.

Commissioner Shrouder asked what former employee refused to speak to counsel. City Attorney Horowitz advised Mr. Bailey.

Commissioner Katzman asked the fund balance in the Water Utility Fund and if the purchase would come from that fund. CFO Williams answered \$34 million with \$16.1 million unassigned.

Mayor Ross said they can use the unassigned amount to fix the meters without raising any other rates.

Commissioner Shrouder asked if the preference is to complete the entire project at once or in portions. City Manager Rey said in portions and they can work within a two year span.

Commissioner Shrouder would like to move forward, the sooner the better for accurate bills.

Mayor Ross would like to update the meters as soon as possible.

Commissioner Katzman asked Director Welch his opinion. Mr. Welch believes the purchase of the AMI system is the City's best option.

City Manager Rey said he has experience with smart meters and Director Welch has spent a lot of time researching the AMI system.

Commissioner Katzman asked if we have existing staff to do repairs. Director Welch answered they have two mechanics from Utilities and two meter readers from Finance. He also advised one individual from the company Core and Main will be dedicated to work with staff.

Mayor Ross asked if the smart meters have a real time response to leaks. Director Welch said the customer will have real time alerts in a customer portal.

Commissioner Katzman asked about billing. Director Welch said the software will intergrade with BS&A. Commissioner Katzman wants to work on a more user friendly billing system for the residents.

Mayor Ross asked if the system keeps track of the alerts sent to the residents.

Commissioner Katzman said he has received an alert concerning water running at his home.

Assistant Finance Director Tena Granit said there is a message released that usage has gone up and the issue is logged into BS&A. The manual meters have no tracking patterns with regard to usage.

City Manager Rey said the AMI system will offer full communication to the residents.

Commissioner Shrouder asked how many meters they had in the City of Sunrise. Director Welch answered 63,000. Commissioner Shrouder asked if they tested the AMI meters. Director Welch answered yes for eight to ten years.

CFO Irwin Williams advised on September 30, 2023, \$20,175,488 million of the General Fund balance was available for spending at the City's discretion in the General Fund. Of the total, \$16.7 million was unassigned and \$3 million was committed for emergency preparedness. \$386,000 was assigned for future encumbrances.

Commissioner Katzman asked what the recommended amount is to have in Fund Balance. CFO Williams said they want to save as much as possible. City Manager Rey said the ICMA recommends 25% of your operating budget as the minimum threshold.

Commissioner Katzman would like a chart indicating what the operating balance is for each fund and what 25% would be.

Commissioner Shrouder said years ago the previous Commission did not have savings in the General Fund. They have worked to lower the millage rate and add savings to the General Fund.

Commissioner Katzman said capital projects require funding and while we will look for grants we may need to spend some money from the General Fund.

Commissioner Shrouder would like to look into all options for sources without using a large amount of savings.

Commissioner Katzman stated he agrees. He does not want to use the entire Fund Balance.

City Manager Rey said very few cities have more than 45% of the operating budget saved. He also advised they identified two positions in Planning that we're working on building permits, reviews and inspections which we have not been charging to the Building Fund. That will free up \$180,000 in the General Fund. City Manager Rey said in between now and September they will be beefing up the CIP.

Commissioner Katzman would like customer service training for the employees. He also thanked staff for the hard work put into the budget. He would also like to start to prepare for playground repairs and refurbishment. He would like to update the splash pad for more usage. Field maintenance is needed and he would like to utilize more field space at Pioneer Middle School. He would also like to work with Broward County regarding upgrades to Brain Piccolo Park. Additionally, he wants to continue to maintain the current trees and beautification efforts including infrastructure.

City Manager Rey agrees they need to continue the maintenance on the current landscapes and infrastructure. Commissioner Katzman said they created four positions to help trim trees and only two positions have been filled. From a policy standpoint the Commission is funding what they are asked to fund but they need staff to deliver the goal.

Commissioner Katzman also spoke on traffic safety. He wants to invest funds in traffic calming as he receives resident concerns.

Mayor Ross spoke on the importance of chargers for electric cars at City Hall and around the City. He also spoke on organizations that help the residents and the requests for donations. He would like to have a healthy discussion on the issue.

Commissioner Shrouder would like to have a policy.

Commissioner Katzman said while he loves supporting those organizations it is the resident's money and he feels that they should decide.

Mayor Ross said the residents are the ones that need the assistance from the organizations. He just recently received a letter from the Area Agency on Aging who gave Cooper City a 40 year award and that was the year we decided not to donate anymore. He would like to have a process in place, dedicating funds including an application process. It is an important item to address.
