**TITLE:** Ordinance 24-16 (Finance)

**DATE:** August 27, 2024

**DESCRIPTION:** AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING ORDINANCE NO. 23-21, ADOPTED ON SEPTEMBER 26, 2023, AS AMENDED; PROVIDING FOR AN AMENDED BUDGET FOR FISCAL YEAR 2023-2024 FOR THE CITY, ATTACHED HERETO AS EXHIBIT "A" AND INCORPORATED HEREIN; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**CITY MANAGER RECOMMENDATION:**

The City Manager recommends approval of Ordinance 24-16, authorization to increase the FY2024 budget to reflect the awarding of the Federal appropriation in the amount of \$959,757 to fund sewer lining rehabilitation inflow and filtration work.

**BACKGROUND OF ITEM:**

The City requires a significant investment in its sewer infrastructure of approximately \$4,000,000. Accordingly, the City asked Congresswoman Debbie Wasserman Schultz to apply for the Omnibus Appropriations funding for this project. On April 11, 2024 the City was informed that the final bill was signed and that an appropriation was approved in the amount of \$959,757. There is no local match requirement as part of this award.
