


WASTEWATER

- Completed normal sewer main jetting.
- Completed turbo blower maintenance

INFLUENT




EFFLUENT



WATER

- Completed daily lab samples related to water quality. (pH, Fluoride, Chlorine, Hardness)
- Monthly chemical injection reports were complete and mailed to the IEPA.
- Completed monthly sampling.
- Repaired CL2 line at Well 4
- Replaced heater in Well 2
- Changed light bulbs at all wells
- Completed IEPA mandated replanning of the Lead/Copper sampling plan, currently waiting for approval from the IEPA
- Replaced electric receptacle in well 2 chemical room
