Dear Mr. Soliman:

The Chicago Laborers' District Council Labor Management Cooperation Committee (LMCC) has reviewed the bid-tabulations from the recent bid letting for the City of Crest Hill's 2026 Sanitary Sewer Cleaning and Televising project. The LMCC believes you should consider some valuable information regarding the apparent low bid from Sewertech LLC.

Included is a correspondence, dated June 4, 2026, issued by the Illinois Department of Labor, indicating that Sewertech LLC violated the Illinois Prevailing Wage Act by not paying the proper prevailing wage rates for a project (IDOL Case No.: 2023-PW-PR01-3937).

The LMCC was established to support, promote, and encourage fair contracting in the public construction arena. Illinois Law often requires public construction contracts to be awarded to the lowest responsible bidder. The City of Crest Hill may have reason to examine the facts provided here prior to awarding the 2026 Sanitary Sewer Cleaning and Televising project and deem this contractor as not responsible and, as a result, consider awarding this project to the next lowest responsible bidder.
