City of Crest Hill Code of Ordinances

Summary: The city has used a number of different tow companies over the years to help facilitate the need to tow vehicles and impound vehicles pursuant to the city's ordinances related to towing. They city at one time had four tow companies on the tow list. The list went from four to three, and now there are currently only two companies in town on the tow list. In the past, we have had experiences of one or both tow companies being busy and unable to respond to police tows. In an effort to expedite police services, we are recommending that Todd's Towing, 16100 S Lincoln Hwy in Plainfield, II be added to the CHPD regular, heavy duty, and police tow lists. Todd's Towing has assisted the CHPD multiple times in the past, and we are recommending that they be added full time
