**A RESOLUTION APPROVING A TEMPLATE RIGHT OF WAY USE AGREEMENT  
FOR FIBER OPTIC NETWORK**

---

**WHEREAS**, the City Council of Crest Hill, Will County, Illinois, has the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare; and

**WHEREAS**, the City Council of Crest Hill, Will County, Illinois also has the authority to adopt policies which pertain to its government and affairs, and which will protect the public health, safety, and welfare; and

**WHEREAS**, the Corporate Authorities has previously enacted Chapter 12.28 governing construction of utility facilities in the Crest Hill Right-Of-Way; and

**WHEREAS**, the City of Crest Hill has received inquiries from fiber utility companies regarding the installation of fiber optic network utilities in the City of Crest Hill; and

**WHEREAS**, the City Attorney has developed and drafted a Template Right-Of-Way Use Agreement for Fiber Optic Network, which the Corporate Authorities have determined is to be used in negotiating agreements with fiber utilities desirous of installing fiber optic networks in the City's Right-Of-Way, a copy of which Template Use Agreement is attached hereto and incorporated herein as Exhibit A.

**WHEREAS**, The Corporate Authorities have reviewed Exhibit A and have determined that it should be approved and used by the City Staff in negotiating agreements with fiber utilities, and the any final agreement will be brought to the City Council for final approval.

**NOW, THEREFORE**, be it Resolved by the City Council of the City of Crest Hill, Will County, Illinois, pursuant to its statutory authority, as follows:

**SECTION 1: PREAMBLE.** The City Council hereby finds that all the recitals contained in the preamble to this Resolution are true, correct and complete and are hereby incorporated by reference thereto and made a part hereof.

**SECTION 2: TEMPLATE AGREEMENT APPROVED;** The Corporate Authorities hereby approve Exhibit A and direct City Staff to use it as a starting point for any negotiation with a fiber utility seeking to install fiber in the Crest Hill Right-Of-Way.

**SECTION 3: SEVERABILITY.** If any section, paragraph, clause or provision of this Resolution is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any other provision of this Resolution.

**SECTION 4: REPEALER.** All ordinances, resolutions or orders, or parts thereof, which conflict with the provisions of this Resolution, are to the extent of such conflict hereby repealed.

**SECTION 5: EFFECTIVE DATE.** This Resolution shall be in full force and effect immediately upon its passage and approval, as provided by law.
