**Summary:** Bids were advertised and solicited for qualified contractors to provide unit price costs for the Kelly and Cora Retaining Wall Replacement Improvement.

The city solicited bids through IDOT's construction bulletin and the local newspaper looking for qualified contractors. A total of fourteen (14) local prequalified contractors picked up bids and six (6) submitted bids. The bids were received for the improvement at Crest Hill City Hall until 10:00 AM local time on Thursday, June 26, 2025. Bids were opened and read aloud on Thursday, June 26, 2024, at 10:00 AM in the Council Chambers. The following is a list of the bids received:

I along with our consultant have reviewed the quotes and found them to be correct and in order, and I feel that the bids do reflect the market as it exists today.

While the City will manage the project construction on a day-to-day basis Christopher B. Burke Engineering, Ltd. provide construction assistance and support on a part-time basis during construction.
