**A RESOLUTION ADOPTING A POLICY REGARDING THE INSTALLATION OF  
STOP SIGNS AND YIELD SIGNS IN THE CITY OF CREST HILL AND THE  
PROCEDURE UNDER WHICH SUCH REQUESTS WILL BE PROCESSED**

---

**WHEREAS**, the City Council of Crest Hill, Will County, Illinois, has the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare; and

**WHEREAS**, the City Council of Crest Hill, Will County, Illinois also has the authority to adopt policies which pertain to its government and affairs, and which will protect the public health, safety, and welfare; and

**WHEREAS**, the City of Crest Hill has the authority to regulate pedestrian and vehicular traffic within the Corporate Limits of the City through various means, including the posting of speed limits, placement of Stop and Yield signs, traffic crosswalks, traffic signals and other traffic control measures; and

**WHEREAS**, the City of Crest Hill follows the Illinois Manual for Uniform Traffic Standards, which sets out various warrants and other requirements for the placement of traffic control devices, including stop and yield signs; and

**WHEREAS**, the Corporate Authorities of the City of Crest Hill has determined to adopt a written City Policy which will clarify and inform the City's residents regarding the use and placement of Stop Signs and Yield Signs within the City pursuant to the Manual for Uniform Traffic Standards; and

**WHEREAS**, in addition to the determination to adopt the foregoing policy, the Corporate Authorities have also determined to adopt a procedure by which requests for a Stop Sign or a Yield Sign within the City will be processed; and

**WHEREAS**, the City's Staff has drafted a Stop/Yield Sign Policy, attached hereto as Exhibit A, and a Stop/Yield Sign Request Procedure, attached hereto as Exhibit B; and

**WHEREAS**, the Corporate Authorities have reviewed the Policy and Procedure (Exhibits A and B hereto) and have determined that they should be adopted as the official policy and procedure of the City of Crest Hill and that the Policy shall be placed on the City's Website in both the Engineering and Policy Department sections.

**NOW, THEREFORE**, be it Resolved by the City Council of the City of Crest Hill, Will County, Illinois, pursuant to its statutory authority, as follows:

**SECTION 1: PREAMBLE.** The City Council hereby finds that all the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference thereto and made a part hereof.

**SECTION 2: POLICY ADOPTED.** The Stop/Yield Sign Policy, attached hereto as Exhibit A, is hereby approved, and adopted as the Policy of the City of Crest Hill and shall be placed as general information on the City's Website under the Engineering and Police Department's Sections of the website.

**SECTION 3: PROCEDURE ADOPTED.** The Stop/Yield Sign Request Procedure, attached hereto as Exhibit B, is hereby approved, and adopted as the Procedure by which the City of Crest Hill will process requests for installation of a Stop or Yield sign. A copy of the Procedure shall be kept and available within the City's Engineering Department, Police Department, Clerk's Office, and City Administrator's Office.

**SECTION 4: SEVERABILITY.** If any section, paragraph, clause, or provision of this Resolution is held invalid, the invalidity of such section, paragraph, clause, or provision shall not affect any other provision of this Resolution.

**SECTION 5: REPEALER.** All ordinances, resolutions or orders, or parts thereof, which conflict with the provisions of this Resolution, are to the extent of such conflict hereby repealed.

**SECTION 6: EFFECTIVE DATE.** This Resolution shall be in full force and effect immediately upon its passage and approval, as provided by law.
