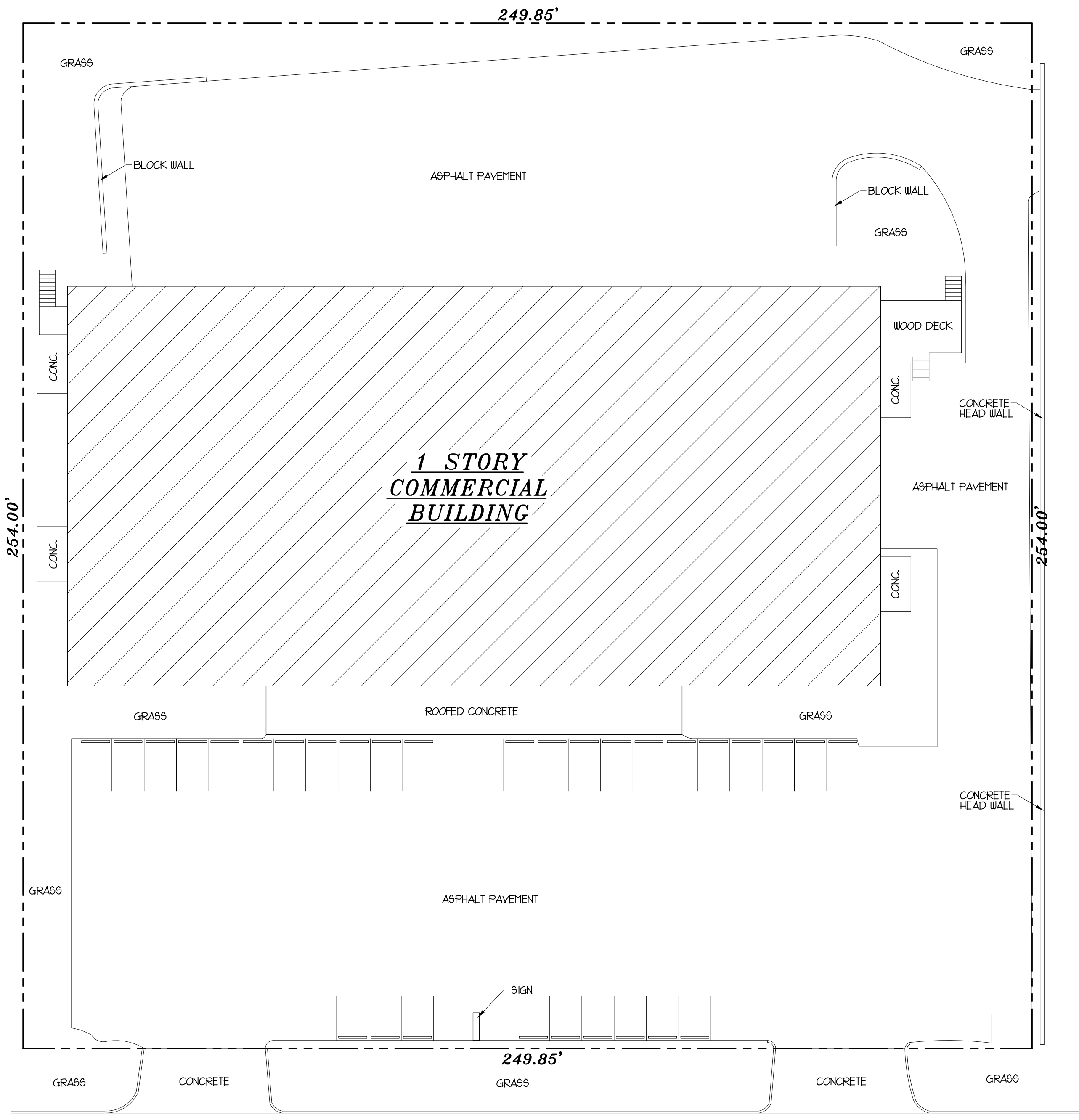

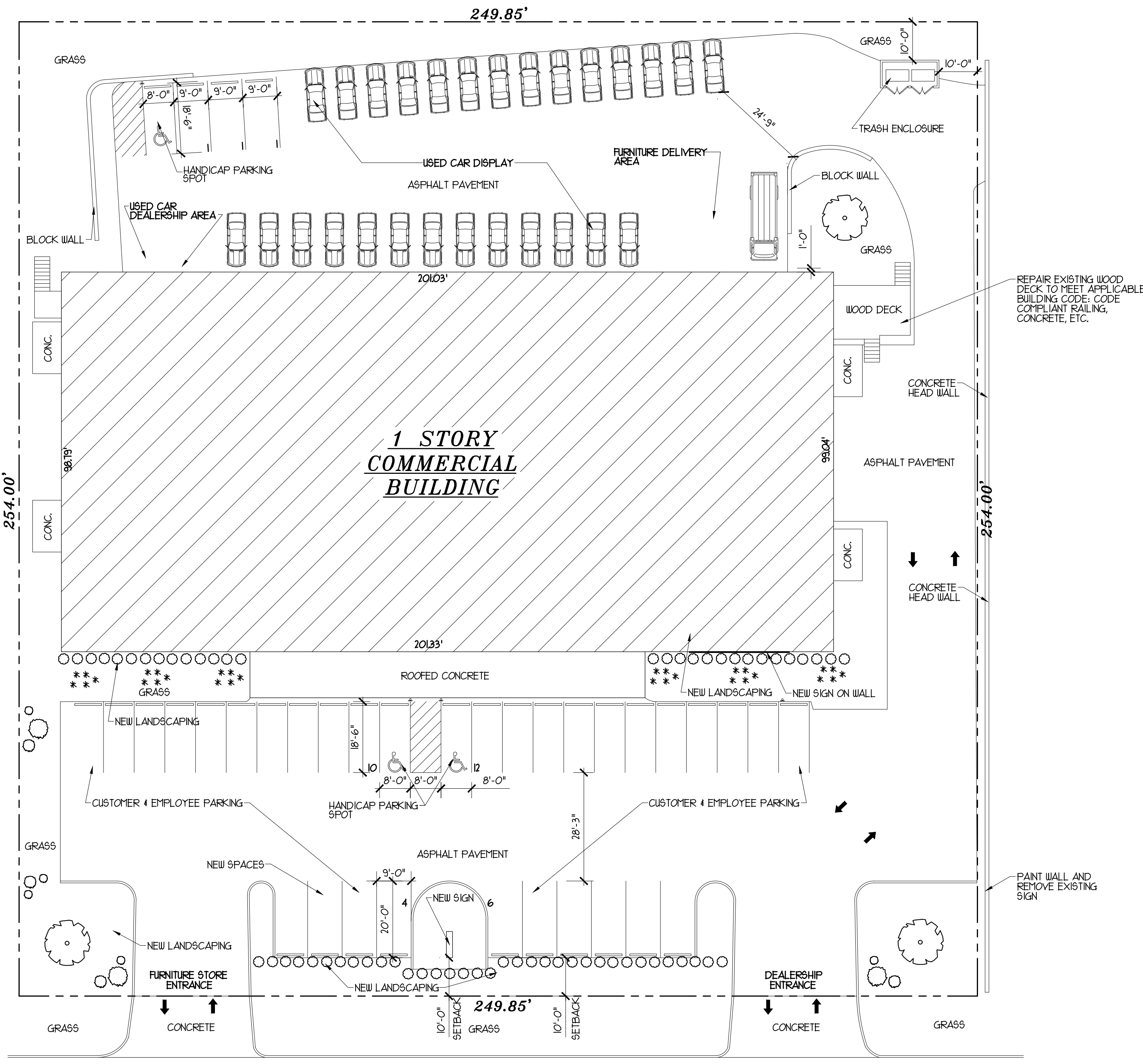
EXISTING SITE PLAN

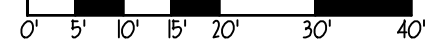

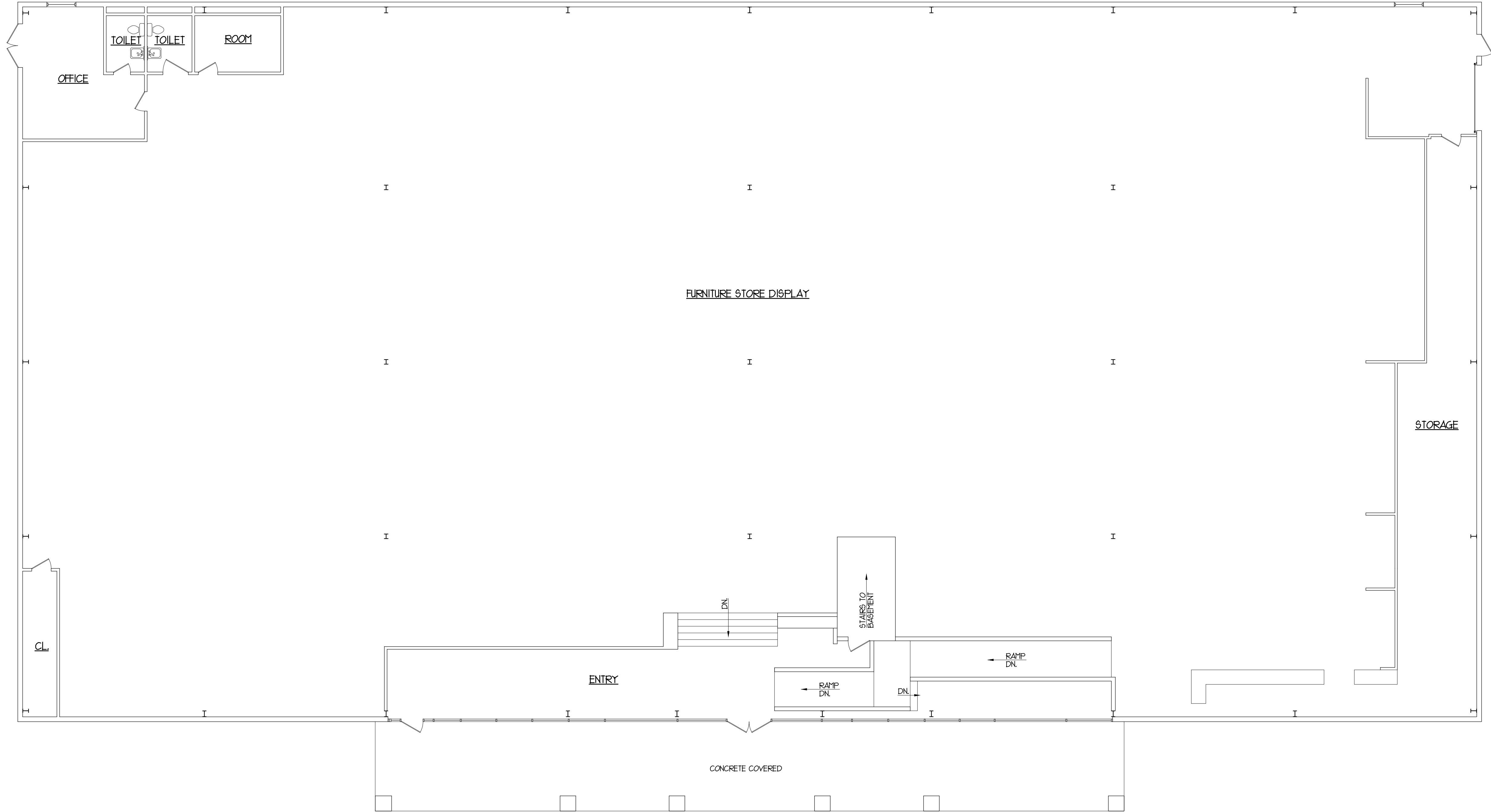

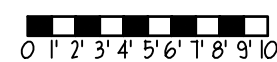

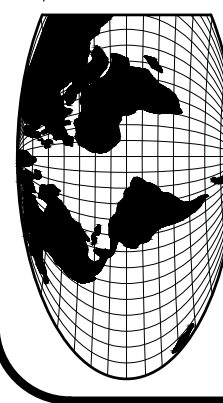


PROPOSED LOWER FLOOR PLAN

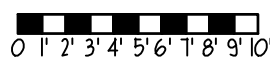
EXISTING REAR ELEVATION

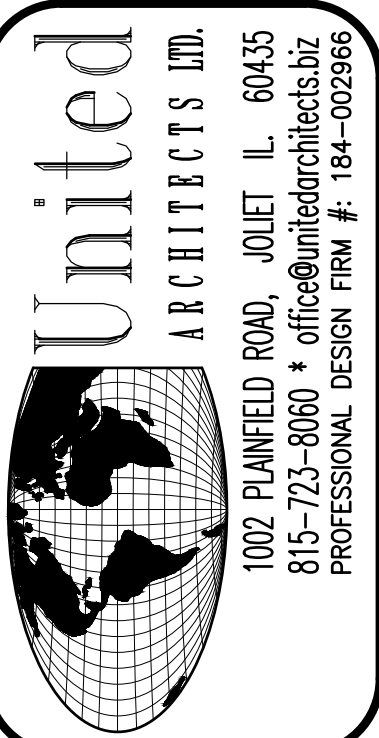
PROPOSED REAR ELEVATION

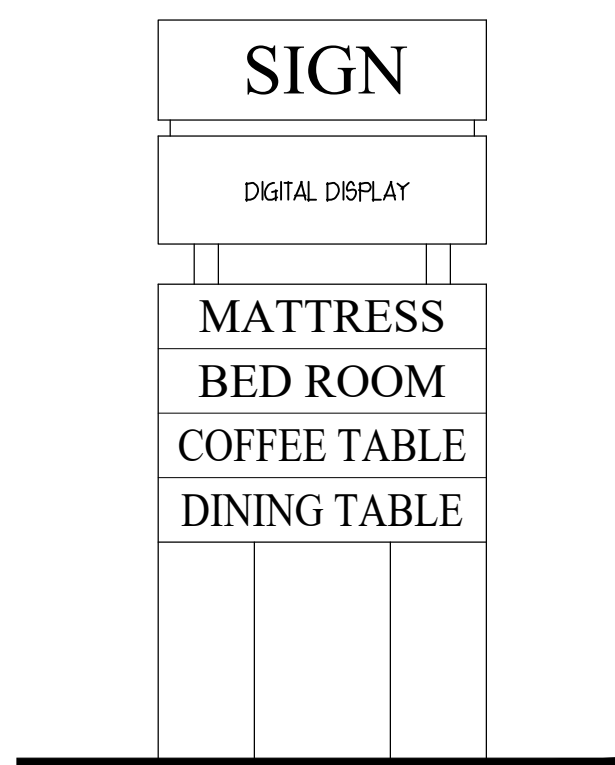
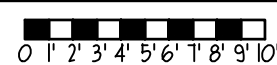
EXISTING FRONT ELEVATION

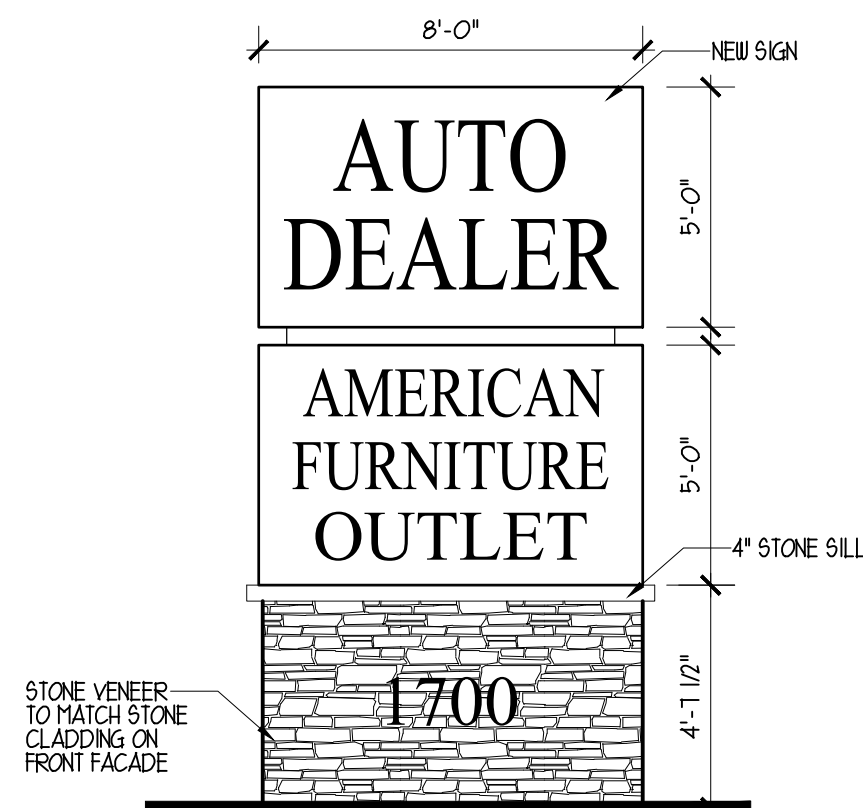
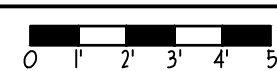
PROPOSED FRONT ELEVATION

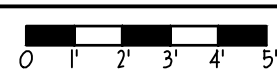
EXISTING SIGN ELEVATION
