**A RESOLUTION APPROVING THE REMOVAL OF GLEN CONKLIN AS  
AUTHORIZED SIGNER ON THE CITY OF CREST HILL FINANCIAL ACCOUNTS  
AND DESIGNATING TREASURER JAMIE MALLOY AS AN AUTHORIZED SIGNER**

**WHEREAS**, the Corporate Authorities of the City of Crest Hill, Will County, Illinois, have the authority to adopt ordinances, resolutions, and rules and regulations that pertain to the City's government and affairs, and which are designed to protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to the general election held on April 1, 2025, Jamie Malloy was elected to the office of Treasurer for the City of Crest Hill; and

**WHEREAS**, on May 5, 2025 outgoing Treasurer Glen Conklin made his last financial report to the City; and

**WHEREAS**, on May 5, 2025 Jamie Malloy was sworn in as Treasurer for the City of Crest Hill; and

**WHEREAS**, Glen Conklin was previously authorized by the City of Crest Hill to be a designated and authorized signer on the City's financial accounts; and

**WHEREAS**, the Corporate Authorities have determined that Glen Conklin should now be removed as an authorized signer and Jamie Malloy be designated as an authorized signer on the City's financial accounts.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Crest Hill, Illinois, pursuant to its statutory authority, as follows:

**SECTION 1: PREAMBLE.** The City Council hereby finds that all the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2: GLEN CONKLIN REMOVED AS DESIGNATED SIGNER.** The City Council hereby approves the removal of Glen Conklin as an authorized signer on the City's financial accounts.

**SECTION 3: JAMIE MALLOY HEREBY DESIGNATED AS AUTHORIZED SIGNER.** The City Council hereby designates that Jamie Malloy should be added as an authorized signer on the City's financial accounts.

**SECTION 4: MAYOR AUTHORIZED TO EXECUTE DOCUMENTS EFFECTING THIS RESOLUTION.** The City Council hereby authorizes and directs the Mayor to sign any financial institution forms or documents necessary to effect the intent of this Resolution, which is to remove

Glen Conklin as authorized signer and to approve and designate Jamie Malloy as authorized signer on the City's financial accounts.

**SECTION 5: SEVERABILITY.** If any section, paragraph, clause, or provision of this Resolution is held invalid, the invalidity of such section, paragraph, clause, or provision shall not affect any other provision of this Resolution.

**SECTION 6: REPEALER.** All ordinances, resolutions or orders, or parts thereof, which conflict with the provisions of this Resolution, are to the extent of such conflict hereby repealed.

**SECTION 7: EFFECTIVE DATE.** This Resolution shall be in full force and effect immediately upon its passage.
