RESOLUTION CANVASSING RETURNS AND DECLARING RESULTS OF CITY SPECIAL ELECTION FOR PRECINCT ONE, TWO, THREE, FOUR AND FIVE HELD ON NOVEMBER 5, 2024

WHEREAS, under and by virtue of the Resolution's duly passed by the City Council of the City of Crockett, Texas on August 19, 2024, calling for the special election of Proposition A - Termination of the Crockett Economic and Industrial Development Corporation; and Proposition B - The Repeal of a Sales and Use Tax within the Municipality for the Promotion and Development of New and Expanded Business Enterprises at the Rate of One-Half Percent and the Adoption of an Additional Sales and Use Tax within the Municipality at the Rate of One-Half Percent to be used to Reduce the Property Tax Rate, such election being held on November 5, 2024; and,

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CROCKETT, TEXAS:

<u>SECTION 1:</u> AND IT APPEARING to the City Council of the City of Crockett, Texas that a majority of the votes were <u>FOR</u> the termination of the Crockett Economic and Industrial Development Corporation and the majority of the votes were <u>FOR</u> the Repeal of a Sales

and Use Tax within the Municipality for the Promotion and Development of New and Expanded Business Enterprises at the Rate of One-Half Percent and the Adoption of an Additional Sales and Use Tax within the Municipality at the Rate of One-Half Percent to be used to Reduce the Property Tax Rate; and they have therefore duly passed.
