COUNTY APPRAISAL DISTRICT FOR 2025-2026

Chief Appraiser Carey Minter

Per the State Property Tax Code, each voting entity needs to <u>nominate</u> 1-5 candidates to fill the positions for the Houston County Appraisal District <u>Board of Directors for 2026-2027</u>. This needs to be completed by resolution in a regular meeting of the taxing entity.

The following is specific criteria for nominated candidates.

- 1. The taxing unit may nominate an employee if they are an <u>elected</u> <u>official only</u>. (other employees are not eligible)
- 2. Any citizen that has been a resident of the county for the preceding two years.

The presiding officer of each voting unit's governing body will need to submit the name of the nominees in writing to the Chief Appraiser before *October 15,2025*.

Upon receipt of the nominees, the Chief Appraiser will prepare a ballot listing the nominees and submit this list to the governing bodies <u>before</u> <u>October 30,2025</u>. The taxing units will need to vote on a director <u>before</u> <u>December 1,2025 and submit to the Chief Appraiser before December 15,2025</u>. All votes received after <u>December 15,2025</u> will be forfeited and not counted.

The unit may cast all its votes for one candidate or may distribute the votes among any number of candidates. Some voting units may have enough votes to select several directors to the board. To share representation on the board, several units may wish to vote for the same candidate. A voting unit may cast its votes for a person nominated and named on the ballot. There are no provisions for write in candidates.

The Chief Appraiser will count the votes and declare the candidates who have obtained the most votes <u>before December 31,2025</u>.
