Attention Cosmopolis City Council Members

My name is Nathan Klisiewicz, Shaya Eppler and I own and reside at the home located at 1200 2nd St.

I am writing to request renewal of my temporary RV Dwelling Permit that was granted to me on March 15th 2023 by the Cosmopolis City Council.

I am requesting another 60 day permit (knowing it is the final permit I can obtain) to allow my elderly mother, Laurie Keefe, to remain residing in the RV for another 60 Days.

We have been tirelessly and unsuccessfully working to find her a permanent home within a low income, assisted living or retirement facility since before my 1st RV permit request. I can provide documentation of our efforts and responses if needed. It has proven to be very difficult to find a residence for my 61 year old disabled mother who has a very low + limited income.

It has been brought to our attention numerous times during our efforts, that once she reaches the age of 62 which will be this May 23rd 2023, she will be applicable to apply to even more facilities.

It is my hope that ~~now~~ the City Council members would approve my permit request to allow us the best opportunity to find her a home as soon as possible. I do not desire having the RV on my property nor is it a convenient or easy option for my mother but it is the only option we have right now to keep her from living on the street out of her car and being homeless.
