<b>SUBJECT:</b> Discussion on Fiscal Year 2026 Proposed Tax Rate and set public hearing(s) (if required) on tax rate.
RECOMMENDATION: Consider and appropriate action on setting a date, time, and place for the public hearing(s) for the proposed tax rate for FY 2026.
BACKGROUND: The City's current tax rate is \$0.5233/\$100 assessed valuation. The 2025-2026 Voter-Approval Tax Rate (Rollback Rate) is \$ and the No-New-Revenue Tax Rate (Effective Rate) is \$
If the City Council anticipates adopting a tax rate at or below the No-New-Revenue Tax Rate, no public hearing is required. However, if the City Council anticipates adopting a tax rate in excess of the No-New-Revenue Tax Rate, the City is required to hold two (2) public hearings and publish newspaper ads before adopting a tax rate that exceeds the Voter-Approval Tax Rate, whichever rate is lower.
Staff recommendations are for the City Council to call the public hearings for August 12, 2025, and August 26, 2025, to be conducted during the regular scheduled council meetings beginning at 6:00 p.m. in the City Council Chambers.
