Dear David,
Southeastern Tennis Courts proposes to:

**CONVERT THREE TENNIS COURTS INTO ONE TENNIS
AND SIX PERMANENT PICKLEBALL COURTS**

1. Pressure wash the three tennis courts in preparation for resurfacing / conversion.
2. Remove two existing tennis nets and the tennis net posts from two tennis courts and dispose.
3. Install 120' of 10' high fencing to separate the remaining tennis court from the new Pickleball courts.
4. Install 100' of 4' high fencing between the sets of Pickleball courts.
5. Install six net post foundations with sleeves and six center anchors in the proper locations for six new permanent Pickleball courts.
6. Clean the courts as necessary in preparation for resurfacing.
7. Fill all structural cracks with E-330 crack filler, **cracks are not guaranteed against returning and may return at any time unless a Crack Repair System is applied.** **NOTE:** Southeastern Tennis Courts is not responsible for any previously applied crack repair systems.
8. Install 235' of Southeastern Tennis' guaranteed **four part** Premium crack repair system over agreed upon cracks. The Southeastern Tennis' guaranteed **four part** Premium crack repair system consists of an application of a crack isolation tape over the existing cracks. This tape is held in place with **two** separate fabric overlays and a fiberglass membrane perimeter. A **five year warranty** against the treated cracks recurring is included please see the attachment on details. Southeastern Tennis uses a **pure** acrylic adhesive product (this is the primary acrylic in tennis court paint). We do not use an acrylic resurfacer as the adhesive as that is a diluted product and is more prone to delamination of the crack repair. The crack repair system **will not** prevent any new cracking. **NOTE:** New cracks may develop between this date and the date of the actual resurfacing. At Owner's discretion, additional Premium Crack Repair may be installed @ \$ 15.00 per linear foot based on actual footage installed.
9. Apply one coat of black acrylic resurfacer.
10. Apply two coats of fortified Acrytech™ full acrylic playing surface. Acrytech™ Player's Choice colors to be selected by Owner. Acrytech™ Specialty Colors may incur additional charges.
11. Stripe one tennis court using two coats of texturized white line paint.

12. Stripe six Pickleball courts using two coats of texturized white line paint.
13. Paint the existing tennis net posts black and rehang the existing tennis net.
14. Install six new sets of 2-7/8" o.d. external gear black Pickleball net posts.
15. Install six new 3.0 mm Pickleball nets with center straps.
16. Clean the work site thoroughly.

The cost of \$ 71,625.00

TERMS: payable upon job completion

NOTE: This job is to be completed within 60 days (weather permitting).

All described work will be performed in a workmanlike manner and guaranteed for one year from date of completion unless noted above. Resurfacing does not prevent new cracks from forming or existing cracks from elongating, there is **no** guarantee on cracks without a Crack Repair System). Any deviation from the described specifications will be executed upon mutual agreement. We are not responsible for strikes, weather or other unforeseen conditions that may force delays in this proposal. We agree to carry workmen's compensation and public liability insurance, pay sales taxes, old age benefits and unemployment compensation as required by law.

This proposal is valid for 60 days.
