Thank you for the opportunity to provide a proposal for a Pierce 100' mid mount aerial platform. The below pricing is based on a purchasing consortium (i.e; SourceWell, NPPGov LOC, etc.) and includes a \$2,000.00 access fee and any applicable discounts. These consortium contracts have been bid on by most major fire apparatus manufacturers. We can provide information on these consortium contracts for you and your administration to review.

I have generated a revised spec based on our most recent meeting. A line item spec sheet has been provided with these revisions. Pricing for this apparatus is listed below:

## Option #1:

Pre-pay discount (3 equal progress payments) 1<sup>st</sup> payment due upon contract signing, 2<sup>nd</sup> payment due upon midpoint of build schedule, 3<sup>rd</sup> and final payment due upon final inspection and acceptance. (\$32,726.00)

## Option # 2:

Pre-Pay discount (100% due upon contract signing) (\$50,951.00)

This pricing is based on a Detroit Diesel DD13 525 HP engine. A Paccar MX13 510 HP engine would be approximately \$6,000 less and a Cummins X15 606 HP would be approximately \$23,000 more than the total price provided. All of these engines have 1850 ft. lbs. of torque.

Pricing includes the apparatus itself with ground ladders, pike poles, wheel chocks, and flashlights as specified. Other loose equipment as required by NFPA is not included.

A performance bond is included in this pricing.

Current build time is 12 to 14 months after receipt of order.
