Mr. Wilson stated the negotiations have gone well and the family has agreed to sell the lot to the city for the price of \$350,000 and a motion could be made for the Mayor approve the agreement and to sign the contract if everyone was ready to move forward with the sale.

Mayor King called for a motion to approve the purchase of property at 446 McMillan Road and authorize the Mayor to sign the purchase agreement.
