POLICE DEPARTMENT

Crime and Crash Statistics for November 2022

Police Chief Cliff Cason gave a written and oral summary of the Crime and Crash Statistical Reports for the month of November 2022. As noted in the written summary, Chief Cason reported the rate of Year to Date Part I crimes are approximately 7.8% lower and Part II crimes are approximately 27% lower when compared to the past 5-year average. Chief Cason further reported there were 132 non-private property crashes reported for the month and non-injury crashes increased from September 2022.

Financial Statistics for November 2022

Police Chief Cliff Cason presented the Financial Report for all divisions within the Dalton Police Department for the month of November 2022.
