Thompson continued stating that the Asset allocation remains in compliance with the policy.

Thompson reviewed the Asset Allocation & Performance of the Plans funds stating it will be only the 5th year since 1999, the Plan has had a negative Return. Thompson stated after review, SEAS feels the Plan is well diversified and they are not looking at adding/changing any further asset classes. On the motion of Trustee Mock, second Trustee Carvell, the Board approved the report. The vote was unanimous in favor. A copy of the complete report is a part of these minutes.
