# TRAFFIC CONTROL CHANGE REQUEST

SPENCER STREET AND HAGEN STREET INTERSECTION ALL-WAY STOP

JUNE 2<sup>ND</sup>, 2025

THIS REQUEST IS TO CONVERT THE EXISTING TWO-WAY STOP FOR HAGEN STREET TRAFFIC APPROACHING THE SPENCER STREET INTERSECTION INTO AN ALL-WAY STOP TO MITIGATE EXISTING SIGHT DISTANCE CONSTRAINTS. AFTER EVALUATION OF THE INTERSECTION SIGHT DISTANCE FOR HAGEN STREET, PUBLIC WORKS STAFF HAVE DEEMED THIS REQUEST TO BE NECESSARY TO MEET CURRENT AASHTO AND MUTCD STANDARDS FOR ALLOWABLE INTERSECTION SIGHT DISTANCE FOR HAGEN STREET EAST-BOUND TRAFFIC (CROSSING AND RIGHT-TURNS ONTO SPENCER STREET) AND WEST-BOUND TRAFFIC (CROSSING AND LEFT-TURNS ONTO SPENCER STREET). THIS REQUEST RECEIVED POSITIVE RECOMMENDATION BY THE PUBLIC WORKS COMMITTEE FOR CONSIDERATION BY MAYOR AND COUNCIL. SHOULD THIS REQUEST BE APPROVED, THE PUBLIC WORKS DEPARTMENT WILL INSTALL THE REQUIRED TRAFFIC CONTROL DEVICES FOR THE ALL-WAY STOP, AS DENOTED IN EXHIBIT 'A', AS WELL AS ADVANCE WARNING SIGNS.

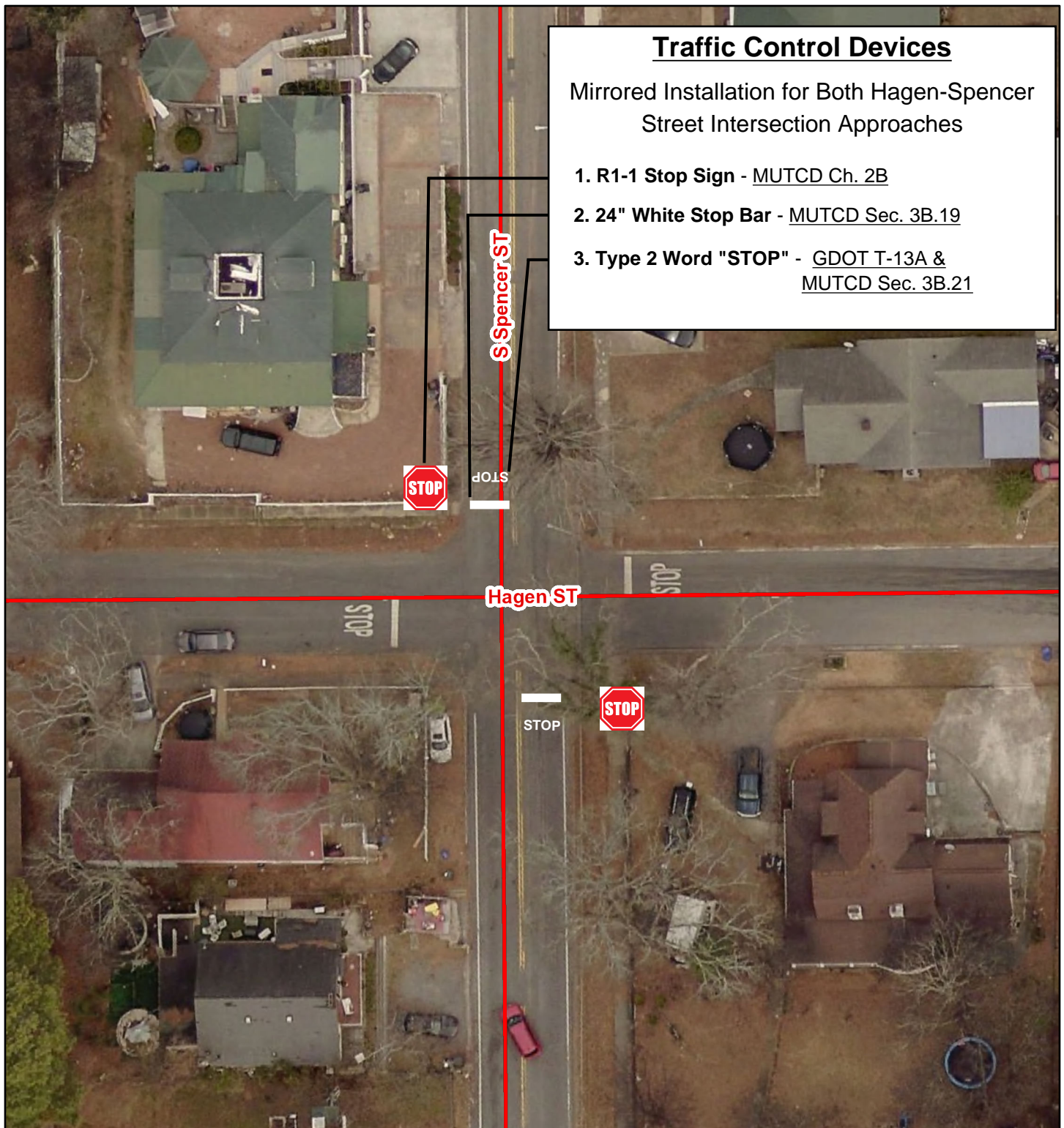
