POLICE DEPARTMENT

Crime and Crash Statistics for March 2025

Assistant Chief Chris Crossen gave a written and oral summary of the Crime and Crash Statistical Reports for the month of March 2025. As noted in the written summary, Assistant Chief Crossen reported the Year to Date Part I crimes are approximately 26.36% lower, Part II crimes are approximately 19.4% lower, violent crimes are approximately 4% lower, and Property Crimes are approximately 28.6% lower when compared to the past 5-year average. Assistant Chief Crossen further reported there were 118 non-private property crashes reported for the month, an increase from the previous month.

On the motion of Commissioner Brown, second Commissioner Jackson, the March Crime and Crash statistic report was approved. The complete report in its entirety is a part of these minutes. The vote was unanimous in favor.

Financial Statistics for March 2025

Assistant Chief Chris Crossen presented the Financial Report for all divisions within the Dalton Police Department for the month of March 2025. Assistant Chief Crossen reported the department has expended 24.5% of the budget and is on track for the remainder of FY 2025.

FIRE DEPARTMENT

Monthly Statistical Report - March 2025

Fire Chief Matt Daniel presented the March 2025 Statistical Report to the Commission. Chief Daniel outlined details of the complete report, which included the Incident Report with 356 Total Responses, Incidents by Staff hours, Incidents by Months and Stations, Average Response Time, Average Turnout Time, Average Travel Time, Injury and Property Loss, Training Division Monthly Report, and the Inspection Summary.

On the motion of Commissioner Brown, second Commissioner Jackson, the Commissioners approved the Statistical Report for the Fire Department. A copy of the report is a part of these minutes. The vote was unanimous in favor.

Monthly Financial Report - March 2025

Fire Chief Matt Daniel presented the Financial Report for the month of March 2025 to the Commission. Chief Daniel stated the department has expended 22.2% of the budget, and is on track for the remainder of FY 2025.
