1. Motor Vehicle Branch Office Agreement

City Administrator Dustin Dassinger presents the agreement between the State of ND acting by and through its DOT and the City of Dickinson. The Dickinson Motor Vehicle Branch Office, City of Dickinson, will occupy the space at T-Rex Mall, beginning on July 1, 2025 through December 31, 2026. City of Dickinson will pay Driver License \$1,500.00 monthly starting January 1, 2027 thru June 30, 2027 for the 1233.79 square feet they will occupy in the Driver License space in the T-Rex Mall. On July 1, 2027 the monthly sublease amount will be re-evaluated.

This Agreement is effective on July 1, 2025, and shall terminate on June 30, 2030. There was a typo on the contract that was received that today and we have asked that it be corrected.

City Attorney Christina Wenko has reviewed and says it is a very standard agreement. There will be a lull in services – there will be about a week lag and the public will be notified. Soft opening July 7th or 8th approximately.
