Ms. Melissa Sitton states that the trap club plays a very valuable role in a children live. This club brings people together and a family unity. The kids connect with parents through

positive settings. Also, business owners get to know each other. This club provides the exposure for students to be on the radar for colleges across the country.

Ms. Kari Roller states that this club is by the Crooked Crane Trail. Private events can be held there also. They will be breaking ground on a new building.

Commissioner John Odermann questions what will be done with the old building. This club is a great element for the community.

Ms. Roller states that the old budling is pretty sad and it has served the purpose.

Commissioner Joe Ridl states this is a great program and good see all the success that it has had.

B. Sunrise Youth Bureau Annual Presentation

Sunrise Youth Bureau Director Holly Praus thanks the Commissioners for having them to present and for the continued support. Ms. Praus states the funds from the City of Dickinson are used to help assist with the current programming. That includes Diversion/Crisis Suspension, Education/Prevention, Out-of-School Intervention. Care/Attendant Care. She states they work with local law enforcement by being a safe place for youth to in the middle of the night. Whether it is a youth getting a delinquent charge, a runaway youth, or a youth needing time away from a conflict at home or a domestic Ms. Praus states they help the local Human Service Zones if they need placement for a youth. Also help the local schools by providing prevention programs. This may include education on drugs, alcohol, vaping; respect and rules, manners, bullying, etc. We also help our local schools by providing OSS. They have seen a huge increase in our out-of-school suspension numbers from last year to this year. In 2024 there were 52 students. She states if parents are struggling with a defiant youth at home Sunrise works with a parent and child by explaining the juvenile justice system and what can happen if they continue this behavior. They give them classes on what they may struggle with. This can include anger management, conflict resolution, making good choices, self-esteem, etc. She states without the support of the City, Counties, and partnering agencies, whom we have contracts with, we couldn't provide these services. Sunrise Youth Bureau appreciates the continued support.

Commissioner Robert Baer commends staff at the Sunrise Youth Bureau for doing a tremendous job. This is a tough job but rewarding.

C. Rezoning Request – Community Orchard Rezone

City County Planner Steven Josephson presents a rezoning request for the Community Orchard. He states the applicant is requesting the approval of a zoning map amendment from unzone and Community Commercial to Public for Part of Block 4 of the Nuhaven Second Addition Subdivision, located within the City of Dickinson.
