**1. Background Data:**

- a. Effective Date of Task Order: February 7, 2023

**2. Description of Modifications**

- a. Engineer shall perform the following Additional Services:

The City of Dickinson, during the development of the final project plans and specifications, applied for project funding through the North Dakota Clean Water State Revolving Fund (CWSRF) for a low interest loan and for grant funding under a CWSRF related “Emerging Contaminant” Grant program.

In support of these applications HEI completed coordination with the North Dakota Department of Environmental Quality (NDDEQ) staff to help complete the application process for each grant. To support the funding application HEI completed the required project facility plan report for NDDEQ consideration to vet the project for applicability of the funding sources.

The specific requirements of the CWSRF funding required specific language modification in the project documents and an additional public hearing on the project to secure grant funding. HEI supported the application process with a public hearing for the project, revisions to the project manual and active management of the NDDEQ’s project tracking system.

As part of the CWSRF funding commitments the NDDEQ staff required periodic project inspections onsite with the Engineer and Resident Project Representative. Inspection documentation included final construction documentation uploads to the project tracking system and tracking the Build America, Buy America (BABA) materials used in the project.

Support closeout documentation of the project construction for the CWSRF loan and Emerging Grant programs.

- d. For the Additional Services or the modifications to services set forth above, Owner shall pay Engineer the following additional or modified compensation: \$26,700
