Community Development staff is requesting adoption of an updated Transportation Master Plan and Comprehensive Plan Update. This update updates numerous policies from the 2013 Transportation Master Plan, including reducing the required right-of-way dedication width, altering the required spacing between driveway approaches, and adding additional housing and land use policies.

Staff recommendation: Staff recommends approval of this comprehensive plan update.

The proposed Transportation Master Plan and Comprehensive Plan Update is included with this staff report.

STAFF ANALYSIS

BACKGROUND

City staff has been working alongside KLJ Engineering to develop the Direction 2050 Transportation Master Plan and Comprehensive Plan Update. This plan was officially accepted by the City Commission at the October 21st, 2025 City Commission meeting.

COMPATIBILITY, COMPLIANCE, AND RECOMMENDATIONS

Compatibility with the Municipal Code

City staff is recommending the City repeal the existing 2013 Transportation Master Plan and adopt the proposed Transportation Master Plan and Comprehensive Plan Update. The proposed plan reduces the required right-of-way dedication and road sections for all classifications of streets to encourage reduced infrastructure costs for developers. Additionally, multiple options for both urban local and urban collector roads are being proposed, to allow for flexibility on how streets are designed for residential, commercial, and industrial areas. Last, the proposed plan reduces the distance required between intersections and driveways.

PUBLIC INPUT AND STAFF RECOMMENDATION

Public Input: Numerous public engagement meetings were held by KLJ Engineering during the process to gather feedback from residents about different aspects of the updated plan.

Staff Recommendation: The City Development Team staff recommends **approval** of CPU-001-2026.
