As used in this Order, the terms (a) "Seller" shall mean the authorized Dealer to whom this Order is addressed and who shall become a party hereto by acceptance hereof, (b) "Purchaser" shall mean the party executing this order as such on the face hereof, and (c), "Manufacturer" shall mean the company that manufactured the equipment, it being understood by Purchaser and Seller that Seller is in no respect agent of manufacturer, that Seller and Purchaser are the sole parties to this Order and that reference to Manufacturer herein is for the purpose of explaining generally certain contractual relationships existing between Seller and Manufacturer with respect to new equipment.

2. Manufacturer has reserved the right to change the price to Dealer of new equipment without notice. In the event the price to Dealer of new equipment of model ordered hereunder is changed by Manufacturer prior to delivery of the new equipment ordered hereunder to Purchaser, Dealers reserves the right to Change the cash delivered price of such equipment to Purchaser accordingly. If such cash delivered price is increased by Dealer, Purchaser may, if dissatisfied therewith, cancel this order

3. If the used equipment which has been traded in as part of the consideration for the equipment ordered hereunder is not to be delivered to Dealer after agreed upon continued usage, the used equipment shall be reappraised at the time it can be inspected and reconditioned. Such reappraised value shall determine the allowance made for such equipment. If such reappraised value is lower than the original allowance therefore shown on the front of this Order, Purchaser may, if dissatisfied therewith, cancel this order, provided, however, that such right to cancel is exercised prior to delivery of the equipment ordered hereunder to the Purchaser and surrender of the used equipment to the dealer.

4. Purchaser warrants any such used equipment to be his property free and clear of all liens, including blanket liens, and encumbrances except as otherwise noted herein.

Unless this Order shall have been cancelled by Purchaser under and in accordance with the provisions of paragraph 2 or 3 above, Dealer shall have the right, upon failure or refusal of Purchaser to accept delivery of the equipment ordered hereunder and to comply with the terms of this Order, to retain as liquidated damages any cash deposit made by Purchaser.

6. Manufacturer has reserved the right to change the design of any new equipment, accessories, or parts thereof at anytime without notice and without obligation to make the same or any similar change upon any equipment, accessories, or parts thereof previously purchased by or shipped to Dealer or being manufactured or sold in accordance with Dealer's orders. Correspondingly, in the event of such change by Manufacturer, Dealer shall have no obligation to Purchaser to make the same or any similar change in any equipment, accessories, or parts thereof covered by this Order either before or subsequent to delivery thereof to Purchaser.

7. Dealer shall not be liable for failure to deliver or delay in delivering the equipment covered by this Order where such failure or delay is due, in whole or in part, to any cause beyond the control or without the fault or negligence of Dealer.

8. Dealer shall not be liable for any incidental or consequential damages to property, including but not limited to damages for loss of use, loss of time, loss of profit or income, or any other such damage.

9. If a trade is listed on this PO and that trade will be used for another season or more, the customer will be responsible to maintain proper machine service and pay for any repairs needed to bring the unit back up to the condition it was when this PO was signed. If the customer trades in a unit that is not in the same condition as when this PO was signed, the trade will be reevaluated in it's current condition and it's value adjusted. This may cause an increase in the trade difference amount. Exceptions to those repairs are listed below.
