What are the **Board Director?**

- 1. The Board has legal responsibility for the operations of the responsibilities of a Library Dickinson Public Library per ND Century Code. Subject to State and Federal laws, the Board has the power and duty to determine regulations and rules governing library property, operations, and services.
 - 2. To adopt policies governing library operations and to adopt and amend library policies.
 - 3. To employ and supervise a library director.
 - 4. To approve annual budget funds ensuring adequate funds for library operations. To approve all library expenditures.
 - 5. To supervise building and grounds regularly. To review facilities to make sure they meet the needs of the library program.
 - 6. The Board may contract other libraries to about better or more efficient provision of services and may approve library contracts to provide services to other entities.
 - 7. To advocate for policies and support legislation for the greatest good to the greatest number of library users. To work cooperatively with government officials to maintain positive public relations and advocate for the library.
 - 8. The board will establish by-laws for the library.

What are the responsibilities of the Administration?

- 1. Attend all Board meeting (unless excused) and serve as executive officer and lead advisor to the Board.
- Library Director and Library 2. Enact the policies adopted by the Board of Directors.
 - 3. Make recommendations regarding the facility, personnel, and policies of the library.
 - 4. Supervise all personnel and volunteers, within library selections and policies.
 - 5. Under direction of the Board, make decisions regarding budget & expenditures, including purchases within the library's selections purchasing policies.
 - 6. Supervise building, grounds, and bookmobile.

Why do you want to serve on the Library Board?

I want to serve on the Library Board to uphold the library's policies, help the library continue to grow and thrive, support the library staff, help the community continue to be aware of the library's services, support continued adequate funding, and support this excellent resource in our community. I think the no censorship policy is an important part of the library's work. All patrons can choose the material they want to access. Every family can choose what is in their own home and what they want their children to read and take part in. The library's mission is to make resources available to all families and citizens. This means that some of the materials in the library will not be used by all citizens or all families. Parents are responsible to monitor what their children check out at the library. The library is responsible for offering an uncensored selection of material for the community.

Why is the library important Libraries are one of the most important resources in a for our community and why community. Libraries are accessible and welcoming to is it a necessary government service?

EVERYONE! Staff members are trained as information-finding experts, assisting community members in finding information that can be difficult to locate. Because the library serves everyone in the community, it is an appropriate expenditure for government funds. In addition, the library assists residents at little or no cost with things like computer use including e-mail, fax services, wide information access.

Staff members in our library exhibit expertise and patience as they assist a diverse patron population. Obtaining information is complicated these days because there are so many resources and it takes expertise and funds to gain access. A library can be a community's gateway to knowledge, personal and professional growth, and well-being.

Although they are not charged to do so, libraries also provide informal social service support. People use the library as a warming center in the winter, staff members provide information on local services, staff members are kind and welcoming to everyone who comes through the doors. As a mental health professional, I know that kind words from others have honestly saved lives for people in desperate need of connection at times. I have observed conversations of that level at the library. The staff members form relationships with patrons and are amazingly kind. Citizens in our community utilize the library for necessary services as well as for reading pleasure and enrichment. It is government funding well-spent.
