Task Order No. 2025-2: Lead Service Line Replacement Project

e. Specific Project (description): Project to replace approximately 29 existing lead water service

lines from the curb stop to the meter.

 - The City has identified approximately 29-lead service lines to be replaced from the corporation stop to the meter in the homes/buildings. Temporary construction easements will be procured for lead service line replacements by the City.
 - Base maps will be based on the Cities GIS linework; field survey will not be completed for the project. A ND One-call of utilities will not be completed for the design project.
 - Plans will include standard sheets including cover sheet, detail/notes sheets and lead service line location sheets. Standard City Specifications will be used; updates to City specifications may be utilized.
 - Opinion of Probably Cost will be prepared.
 - No geotechnical exploratory boring will be advanced for the project.
 - Deliverables: 90% and Final Plans
 - SRF requirements will be included in the contract documents.
