# A. Chapter 39 Amendment – Group Living

City/County Planner Steven Josephson presents a Chapter 39 Ordinance Amendment for a second reading to allow the City to approve group living facilities, transitional housing, family shelters and group facilities. Mr. Josephson had received a call from the sober house individuals and he states this change to the ordinance does not affect sober homes.

President Scott Decker states that he had received a call to see if the city would have sufficient teeth in this ordinance that if there are violations at the proposed site that the City would be able to step in and shut it down.

Planner Josephson states the City is going to require an annual assessment and the homes will need to submit to Planning and Zoning and there will be an annual renewal for these homes. If there are complaints the City does have the power to revoke the special use permit. A fence or berm will be for the screening.

### E. East Broadway Dam Contract Amendment with Barr Engineering Co.

Engineer and Community Development Director Joshua Skluzacek presents a contract amendment with Barr Engineering Co. to provide final project plans and specifications and bidding assistance for the East Broadway Dam project for a time and expenses basis as specified in the contract for \$155,607.33. The City Attorney has reviewed this contract, and has no additional comments. The project was approved with the 2024 capital improvement project budget, and it is to be paid for using Gross Production Tax (GPT) and the North Dakota Department of Water Resources grant which was approved at the April 2, 2024 City Commission meeting. Director Skluzacek states the scope of work with this contract amendment includes: project management, design drawings and specifications, construction cost estimating, a design report to meet the North Dakota Department of Water Resources Dam Safety Standards, permitting through the State of North Dakota and the United States Army Corps of Engineers, right-of-way services to acquire the property located adjacent to the proposed rock riffles, public engagement, and bidding assistance. City staff recommends approval. Director Skluzacek states this is a series of steps that will occur over a distance of 300-400 feet. Construction would start in 2025.

President Scott Decker states he hopes this does not lower the waterline.

Commissioner Robert Baer states hopes this will incorporate some recreational element with this change. He is hoping there will be to incorporate recreational areas in this area such as a rock to fish off of, etc.

Director Skluzacek states this is a collaborative effort with Parks and Rec and this is the only for the flow of this river.

# 8. PUBLIC HEARING AND PUBLIC COMMENTS NOT ON AGENDA – 5:00 P.M. A. Public Comments not on Agenda

Ms. Tavia Kuntz discusses the cemetery incident prior to the Memorial weekend. She states the public was told it was a massive miscommunication in the Public Works Department. Ms. Kuntz does not understand how this could happen and the cemetery was to be cleaned up why was it not brought before the Commission prior to it being cleaned up.

President Scott Decker states the City passed an ordinance last summer about the cleaning of the cemeteries and at one time the mausoleum was to be cleaned up. Notice was given to everyone with a crypt and this was to be cleaned up. What was done at the mausoleum was also to be done at the cemeteries. The clean up crew was given the authority to clean the cemeteries so they thought they would clean it. President Decker states the workers were given instructions to clean up and there was no malicious order given.

Ms. Kuntz states clean up does not mean to remove memories from plots or headstones and to throw them in the garbage. She feels the City is blaming the workers and that they did not understand. She states someone in leadership had to be given them direction. Ms. Kuntz was not aware of the ordinance that had passed last year. She states thinks were supposed to be attached to the headstones. She questions President Decker that his dad passed away last year and things were not attached to his headstone at the gravesite.

President Scott Decker states a group of people to include grave diggers, funeral homes and staff were working on this ordinance change. He states City staff was receiving

complaints that the City was not doing their job and tending to the cemeteries and not mowing in the proper manner. The ordinance change did have two public meetings.

Ms. Tavia Kuntz questions why her plot was even bothered with as she takes care of the lots herself. She is wondering why all the statues were removed. She states a temporary grave marker was destroyed for her daughter. She feels this is a crime and a desecration to the grave site. She calls every year about taking care of her plot but did not do it this year.

President Scott Decker states he fully understands her concerns and that this was very traumatic for some individuals but in no way did the City try to cause malicious harm to her. She states there is no record of whom takes care of their own family lots.

Public Works Director Aaron Praus states in regards to Ms. Kuntz's question that most people whom want to take care of their own graves do contact the City. They are then given yellow flags to mark the graves they are taking care of. The City does not reach out to individuals each year. The City is looking to start a new program to mark the graves that individuals are taking care of. Mr. Praus states that the items that are left behind are not going to be disposed of in case they are blessed. They will be moved into a building and sit there for people to claim.

Ms. Tavia Kuntz does also have an issue with the park board in regards to Lake View Drive and a tree that has spider mites.

President Scott Decker states Ms. Kuntz will need to contact Parks and Rec.

Mr. David Steinbach questions whether the City advertises the meeting minutes in the newspaper anymore as he cannot find them. He also visited about his property taxes and visiting with Mr. Joe Hirschfeld. He said the City could have sent him a roll of Charmin as it would have been more useful. He states Mr. Hirschfeld told him that someone will purchase Mr. Steinbach's house for whatever the value is. He states it is no use in coming to the City to discuss the valuation as they are going to raise the taxes anyway. He does not know where Mr. Hirschfeld gets his credentials for doing his job. Mr. Steinbach states that after the valuation now they are coming by to replace his sidewalks. He questions how someone can come by and say that a little crack in the concrete needs to be replaced at my expense. He questions what gave the City the right to say that they can do this and charge it back to me. He states he has been in his house for 40 years and states this does not seem fair. He states that he has paid more taxes than his house is worth. He feels Mr. Hirschfeld made a mockery of his rights. He also discusses the water break that had happened and that his house was flooded for 8 months.

President Scott Decker states that the City had multiple meetings in regards to sidewalk improvement and Mr. Steinbach could have replaced the sidewalk by himself. He states this is the first he has heard of Mr. Steinbach's flooding.

Ms. Denita Lampl states what the City did was the worse thing anyone could do to the families and the graves. She states whom was the one who took the items off the headstones. She states her mother-in-law had a glass ornament and it was ripped off. She states her grandson-built poles with lamps and those were removed. She states the family has been taking care of the graves for a long time. She feels they do a better job of taking care of the graves then the City. She states they went out to the grave and nothing was left on the gravesite. It was so sad. Someone should answer for this. She feels that theirs was the first gravesite to be destroyed. Ms. Lampl cannot honestly believe that a human being would go out and destroy gravesites. Those graves are holy and the grave site is holy and the City made it unholy.

Ms. Tavia Kuntz is wondering if the City has any plan for a financial reimbursement to the families.

Public Works Director Aaron Praus mentions to send him an email or claim and he will bring it forward to the Commission.

# 9. <u>COMMISSION</u>

Commissioner Robert Baer states all of this is disturbing and Mr. Dassinger is not here tonight to answer the questions that he has so Mr. Aaron Praus will have to answer the Commissioner Baer states this is very disturbing to him as a commissioner. He states the Commissioners get a notice every time someone gets a 15-minute OT and Mr. Dassinger puts out tidbits weekly but what happened this week. The Commissioner had gone two weeks without anything. Commissioner Baer would like to when something like this happens instead of getting a phone call about the cemetery. As a Commissioner he would like to have had a heads up about this item. He was on the committee that reviewed this ordinance and headstones were never to be touched. He has taken a tour of those cemeteries prior to the ordinance change. Commissioner Baer feels there is something morally wrong with when someone prys off a headstone. He states benches are still in other peoples plots and bushes are still interfering with other people's plots. The intended purpose of the ordinance changes was not what had happened. 
Commissioner Baer has a huge issue with this. He states cemeteries are holy land, statutes are blessed and now they are broken. The City could have done more. He feels City staff have failed the Commission with not letting them know of what went on.

President Scott Decker cannot apologize enough for what has happened and has been visiting with families. He is not the biggest Facebook participant and especially on "What's up Dickinson". He is sorry that the statement was not done quicker. He hopes going forward that the City can make things right. He states again that nothing the City did was malicious. He is sorry from the City.

Commissioner John Odermann states that on his personal account he attends holy hour every Wednesday. He would have a hard time sleeping tonight if he didn't say this as he was personally impacted by this. He states there was stuff by his brothers grave that the family will never get back. He states City cannot fix this but he does want to say that people can fix on how they treat each other. City staff in the days following this incident were driving in City vehicles and they were like they had a target painted on their backs. Citizens were stopping employees and calling them names and saying that you are going to burn in hell. Commissioner Odermann states he loves this community and what it stands for. Social media has leached into our lives and into reality and this is not okay. This should not happen but that is not an excuse to treat people in an undignified manner. If the City wants to continue to have a great community, then we need to treat others with dignity and respect. Individuals should treat each other like the image of God. He states the City cannot fix what happened but will try and make it right as much as the City can. He states the Odermann family will not get back their items. Commissioner Odermann will guarantee one that is that treating people awful is not going to make this community better. He states it is not okay to treat the people who cleaned the cemeteries badly. He states staff called him and stated that if employees are going to be able to provide services that the City provides citizens need to treat each other in the community with dignity and respect that they deserve. This is raw and traumatic for people but it doesn't fix it when they lash out to each other.

Mr. Jeff Ficek states he has been digging graves for 30 years with heavy equipment with respect. He states there are a lot of blessed statutes and a lot of church rights need to be buried when they are done with life. He has not seen any concrete action going forward. He would offer that when the blessed statutes are going to be buried that he would provide the excavation of the grave and to bury these items.
