ARREST CLASSIFICATIONS

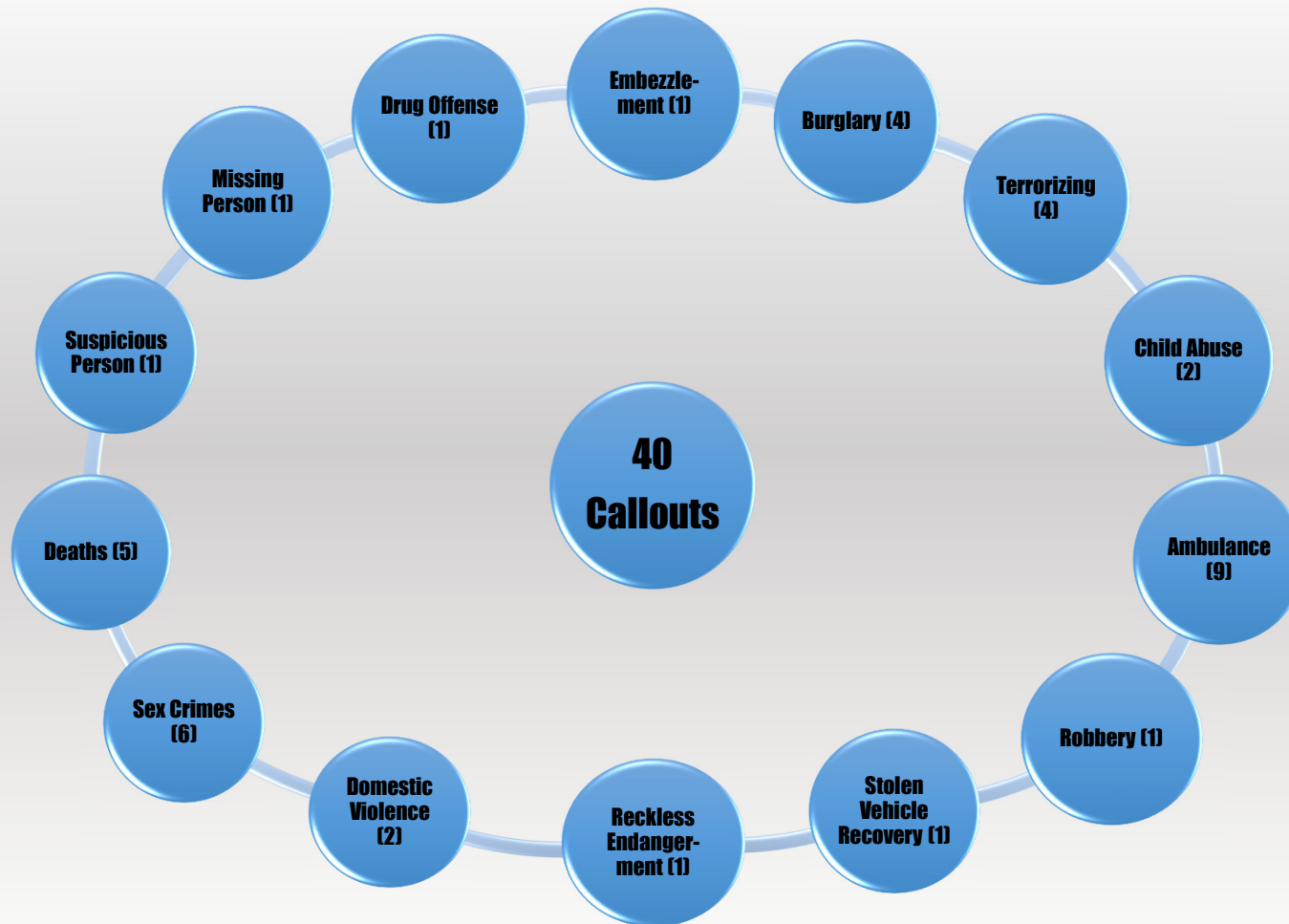

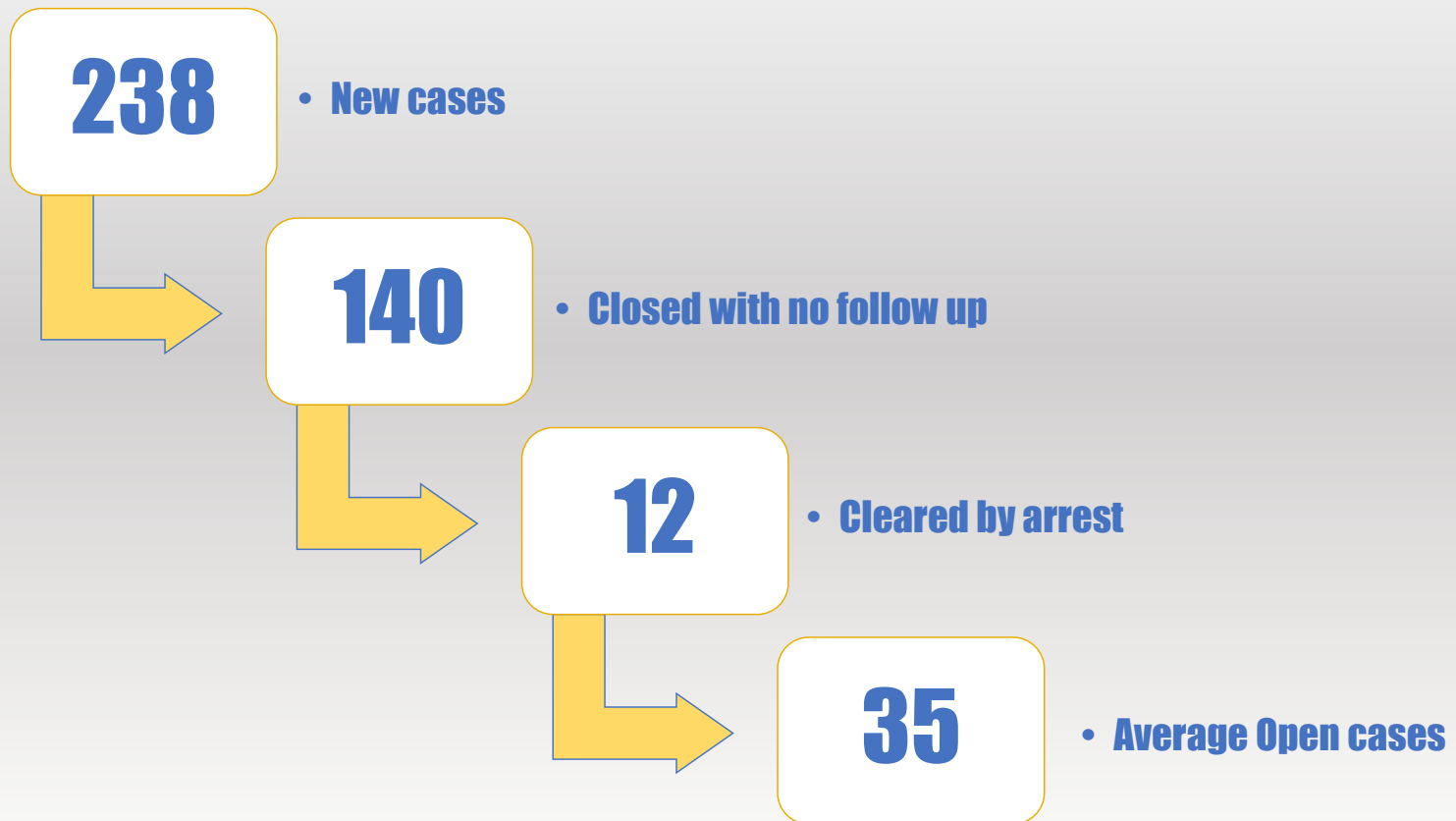

NOTABLE INCIDENTS

- EMS responded to a report of 3yoa drowning in a bathtub. The investigation led to the arrest of SHANNON BESTON & JAVISH MURSHEDI VALDEZ for 2 counts of Child Neglect, Possession of a Controlled Substance & Drug Paraphernalia. Although the 3yoa survived, traces of fentanyl were found in her system and she will be permanently diminished as a result of the incident.
- LUKA DOUGHERTY was arrested for GSI related to a 10yoa victim, the arrest resulted in a second victim coming forward & he is now being investigated on this subsequent GSI – Forcible Rape allegation.
- JEFFREY POWELL was arrested for AA Homicide after fatally shooting his neighbor with a handgun. The 59yoa victim succumbed to his wound at the scene and POWELL was arrested shortly after the incident.
- Four unrelated criminal investigations and Social Services interventions related to children testing positive for Methamphetamine and/or other illicit substances. The victims ranged in age from 1yoa to 9yoa. Charges were filed against parents/caretakers for neglect/abuse.
- DANIEL TETRAULT was arrested for Felony Terrorizing after threatening to kill a female acquaintance and engage her place of employment with a gun.

NOTABLE INCIDENTS

- RAYMOND GENGHINI was arrested for Felony Terrorizing and Felony Aggravated Assault after threatening to kill and subsequently stabbing an acquaintance. The victim sustained non-life-threatening injuries to his leg.
- MYKUL JACKSON was arrested for Discharging a Firearm Within City Limits & A-Misdemeanor Reckless Endangerment in relation to an accidental discharge in a local motel room.
- NICOLE FREELS was arrested for Felony Aggravated Assault and Felony Reckless Endangerment after stabbing an acquaintance in the chest with a knife. The victim sustained a non-life-threatening wound to his chest.
- DANIEL VALENZUELA was arrested for Felony Robbery, Felon in Possession of a Firearm, and Felony Reckless Endangerment amongst other charges after a four-hour stand-off in residence near the Stark County Courthouse. *During negotiation several pistol rounds were fired off by the suspect while inside the residence. The incident stems from the robbery of a local pawn shop where a handgun was stolen. The incident was brought to resolution after negotiations broke down and chemical munitions were deployed by the SWTT.
- CHRISTOPHER GIBSON was arrested for Felony Criminal Conspiracy and multiple Felony Theft charges related to the theft of several motor vehicles and nearly 10 other criminal cases throughout the Dickinson area.

NOTABLE INCIDENTS

- GARY KEEN was arrested for Felony Criminal Mischief & Felony Theft of Property. KEEN stole a residential security camera and later hit/run the resident's garage with a trailer causing thousands of dollars in damage. After identifying KEEN as the suspect it was discovered his trailer and residence contained a significant amount of stolen property from multiple area burglaries.
- LISA TORMASHCY was arrested for Felony Embezzlement associated with the alleged embezzlement of over \$1M in cash from a local contractor over the course of a number of years.
- JOSHUA RUSSELL was arrested on multiple serious Felonies including Terrorizing, Burglary, Reckless Endangerment, Criminal Trespass, & Manufacturing a Controlled Substance following a home invasion. RUSSELL broke through an area resident's front door armed with a handgun. He briefly held the 70yoa homeowner at gunpoint threatening to kill him before rifling through the basement of the residence and then fleeing. RUSSELL surrendered after a short stand-off in his home following multiple hails from the SWTT. A search of RUSSELL'S residence also revealed a marijuana grow operation.



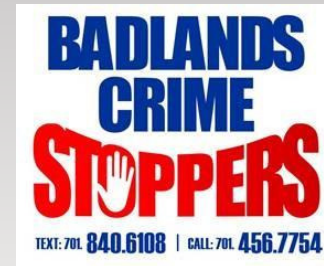

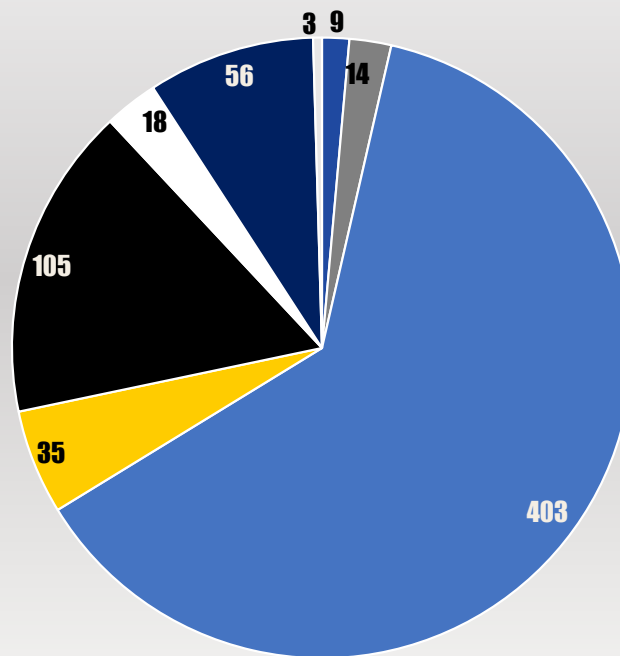

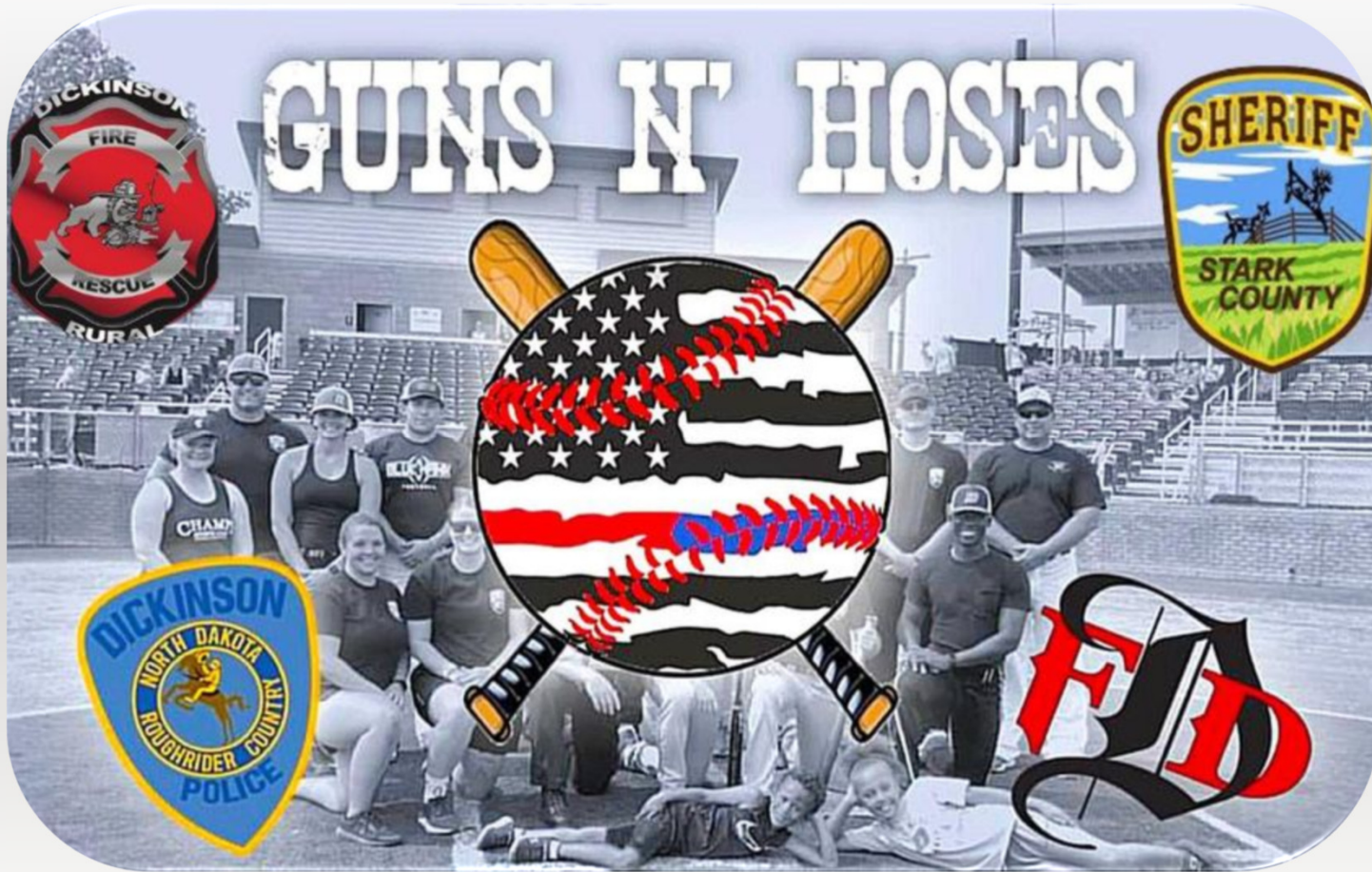
