Approval Of Minutes:

Old Business:

4. Back When They Bucked – May 21-28, 2025

Mrs. Kryger stated reoccurring event, requesting open container and waiver of user fees. Tif Robertson spoke about the event. Mr. Adler moved to approve and recommend to city commission; seconded by Mr. Rock; motion carried unanimously. Discussion was held concerning security and parking.

Mrs. Martinisko stated reoccurring event at the Rec Center, requesting use of Rec Center, waiver of user fees. Mrs. Kryger moved to approve and recommend to city commission, seconded by Mrs. Struble-Mook; motion carried unanimously.

3. Mardi Gras – February 28 – March 1, 2025

Mrs. Kryger stated reoccurring event , requesting street closure, open container and waiver of banner fee. Mr. Rock moved to approve and recommend to city commission, seconded by Mrs. Speirs; motion carried unanimously.

4. 3-Wheeler Rally – July 5 – 11, 2025

Mrs. Kryger stated reoccurring event, requesting street closure and open container. Ren Starks spoke about the event. Discussion was held concerning fees, whether for-profit or private renter. Mrs. Kryger moved to approve the event complex application and recommend to city commission, seconded by Mrs. Speirs; motion carried unanimously. Mrs. Speirs moved to approve parade application and recommend to city commission, seconded by Mr. Rock; motion carried unanimously.

5. Approve Event Complex Application

Mrs. Martinisko spoke about the changes, which are: half the surcharge for additional set-up/tear down, fees must be received, alcohol fee to the fee page and alcohol chapter 5.04 policy. Mr. Rock moved to approve, seconded by Mr. Adler; motion carried unanimously.
