SUBJECT: Public Hearing: Deschutes County 2040 Comprehensive Plan Update

The Deschutes County Planning Commission will conduct a public hearing to consider legislative amendments to repeal and replace the 2030 Comprehensive Plan with the Deschutes County 2040 Comprehensive Plan (file no. 247-23-000644-TA) on October 26, 2023 at 5:30 P.M. The hearing will be held at the Barnes and Sawyer Room, Deschutes Service Center, 1300 Wall Street, Bend. The public hearing will be conducted in-person, electronically, and by phone.

Staff submitted a 35-day Post-Acknowledgement Plan Amendment (PAPA) notice to the Department of Land Conservation and Development on August 30, 2023. Attached to this memorandum are the findings and draft document. The project website contains all record materials – visit <u>www.deschutes.org/2040</u> and click on the "hearings page" to view the official hearing record, from August 30, 2023, onward. The "process page" provides information from the iterative process leading up to the creation of the document.

I. BACKGROUND

The Comprehensive Plan is Deschutes County's policy document for guiding growth and development within the county over a 20-year planning period. The plan's purpose is to provide a policy framework for zoning and land use regulations, demonstrate consistency with statewide goals, rules, and laws, and serve as a cohesive vision for future planning activities.

The project was initiated in April 2022 and progressed through four phases:

- Phase 1 Project Initiation: Hiring of Consultant (MIG, Inc), review of background documents, creation of Community Engagement Plan, project website, and branding materials.
- Phase 2 Initial round of community engagement visioning, review of existing policies with Planning Commission, review of policy best practices in drafting new text.
- Phase 3 Second round of community engagement policy approaches, finalizations of goal and policies, update of maps.
- Phase 4 Compilation of final Comprehensive Plan document, creation of action plan and findings package.

The project has now entered Phase 4, which is focused on the adoption of the updated document. II. PROPOSAL

This is a legislative text amendment to repeal and replace the 2030 Comprehensive Plan, adopted in 2011, with the Deschutes County 2040 Plan. Staff notes that no zoning or comprehensive plan map amendments are being considered, nor are any changes to the County's adopted Goal 5 inventory pertaining to significant natural resources, scenic views, open spaces, mineral and aggregate sites, and historic and cultural resource sites. The Tumalo Community Plan and Transportation System Plan are being updated separately from this process. Updates to the Terrebonne Community Plan and Newberry Country Plan are not included within the scope of this project.

III. PLANNING COMMISSION ROLE

The Planning Commission (PC), as the County's Citizen Involvement Committee, has served as the advisory body overseeing the project. The Planning Commission (PC) met eleven (11) times for the purpose of reviewing Comprehensive Plan materials and providing recommendations throughout the project's duration. Commissioners provided informal comments during these meetings and were not required to make formal recommendations or reach consensus on all topics. The role of Planning Commission at this stage will now shift to be the formal review body. Commissioners will collect public input on the formal plan, and ultimately deliberate on a recommendation to provide to the Board of County Commissioners.

IV. PUBLIC COMMENTS RECEIVED

As of 11 a.m. on the date of this memo, twenty-three comments have been submitted to the record. The comments pertain to a desire for:

- A County strategic plan.
- Area-specific analysis for the Three Rivers census designated place related to water quality, economic development, wildlife, and growth-related issues.
- Greater restrictions on rezoning of farmland.
- Requiring updates to wildlife habitat inventories.

- Limitations on development that could impact natural springs.
- Additional requirements for septic inspections.
- Creation of an amnesty program to remedy violations related to docks.
- Strengthening and enforcement of dark skies lighting.
- Outright allowance for secondary accessory farm dwellings in the MUA-10 zone.
- Moratorium on new development.
- Greater attention to water management, allocation, and infrastructure.
