Goods and/or Services: The Intergovernmental Agreement (#166040) outlines the services and financing of Community Mental Health, Addiction Treatment, Recovery & Prevention, and Problem Gambling Services for January 1, 2021 to December 31, 2021.

This amendment, #8, provides additional funding in the amount of \$253,071 for Service Element #25, Crisis Services. These funds are a reimbursement of unused CCBHC reduction funds.

Background & History:

In 2019 and 2020, the Deschutes County Board of Commissioners approved the signing of Oregon Health Authority (OHA) Intergovernmental Agreement (IGA) #159163-4 and #159163-15 outlining the services and financing of Community Mental Health, Addiction Treatment, Recovery & Prevention, and Problem Gambling Services for the 2019-2021 fiscal years. In these specific amendments, OHA reduced service element funding for the purpose of extending the Certified Community Behavioral Health Clinic (CCBHC) demonstration permitted by the State's Medicaid Plan for the CCBHC.

A total of \$1,360,796 was reduced from the IGAs across several service elements. The unused funds, \$253,071, are being returned to Deschutes County through the Crisis Services service element (MHS 25).
