Hi Rachel,

Sorry it took so long to get back to you but it involved the city as well as MDOT.

MDOT responded that they thought the signage was a city concern so I emailed the city.

The city attorney responded with the following:

"I spoke with Ronald about this today. Our thought is that we are not certain whether the Chevron structure itself conforms with the code or not but that the sign is non- conforming. The position that has been taken with all other commercial properties in that area (Hancock, The First, gas station on opposite side of street, Burger King) has been that the sign ordinance and new downtown design require monument signs upon a change or alteration of the sign. To be consistent the thought is that Chevron will need a monument sign if the current sign has to be moved or altered."

I responded with an email specifically asking if the gas station across the street had been notified about the signage and the answer was yes. So, the signage was a city concern.
