

RESOLUTION AUTHORIZING SUBMITTAL OF GRANT APPLICATION TO THE UNITED STATES DEPARTMENT OF TRANSPORTATION FOR FY2022 REBUILDING AMERICAN INFRASTRUCTURE WITH SUSTAINABILITY AND EQUITY (RAISE) PROGRAM FUNDING, COMMITTING LOCAL MATCHING FUNDS AND FOR OTHER RELATED PURPOSES.

WHEREAS, the U. S. Department of Transportation, is accepting grant applications for funds available through the FY21 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant program for investment in road, rail, transit and port projects that have significant local or regional impact; an opportunity to obtain funding for multi-modal, multi-jurisdictional projects that are more difficult to support through traditional Department of Transportation programs; and

WHEREAS, the City of Diamondhead deems it to be in the best interest of the citizens of the City to seek funds necessary through the RAISE grant program for a Commercial District Transformational Project that will include new roadway corridors to support commercial frontage roads, improved traffic flow and connect inaccessible segments of the City.

NOW, THEREFORE, IT IS HEREBY ORDERED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DIAMONDHEAD, MISSISSIPPI, that:

SECTION ONE: Michael Reso, City Manager of the City of Diamondhead, is hereby authorized and directed to submit an application to the U. S. Department of Transportation FY22 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant program funding, and along with said application, all understandings and assurances contained therein and to provide such additional information as may be required; and

SECTION TWO: Provided the City is awarded FY22 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) program funding through the U. S. Department of Transportation for the total project cost in the amount of \$11,000,000 with a federal share of \$10,000,000 the City of Diamondhead agrees to provide matching funds of at least ten percent (10%) or \$1,000,000.

SECTION THREE: Michael Reso, City Manager of the City of Diamondhead, is hereby authorized to publish any and all necessary notices as applicable in accordance with the guidelines governing the FY22 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant Program; and

SECTION FOUR: Michael Reso, City Manager of the City of Diamondhead, is hereby authorized to execute any and all documents necessary and pertinent to the application; and

SECTION FIVE: Michael Reso, City Manager of the City of Diamondhead, is hereby authorized to execute a grant offer and any other documents necessary to the acceptance and implementation of the program should the project be approved.
